Summary: Establishes the circumstances under which various types of residential care facilities are permitted.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Table 2 of the Land Use Tables adopted in Subchapter 19A.04.010 of the Zoning Code of the City of Las Vegas is hereby amended by deleting from the "Residential & Lodging" element of Table 2 the row pertaining to "Residential Care Facility."

SECTION 2: Table 2 of the Land Use Tables adopted in Subchapter 19A.04.010 of the Zoning Code of the City of Las Vegas is hereby amended by adding thereto, at the appropriate locations, two new rows, pertaining respectively to the uses "Individual Residential Care Facility" and "Group Residential Care Facility," appearing as follows:

SECTION 4: Table 2 of the Land Use Tables adopted in Subchapter 19A.04.010 of the Zoning Code of the City of Las Vegas is hereby amended by adding thereto a new row pertaining to

the use "Transitional Living Group Home," reading as follows:

SECTION 5: Section 19A.04.040(B) of the Zoning Code of the City of Las Vegas is hereby amended by adding thereto, in its corresponding location, a new subsection entitled "GROUP RESIDENTIAL CARE FACILITY," reading as follows:

GROUP RESIDENTIAL CARE FACILITY [U, R-A, R-E, R-D, R-1, R-CL, R-2, R-3, R-4, R-5]

1. The facility must be located on a parcel with a minimum size of 6,500 square feet.
2. Off-street parking shall be provided on the basis of at least one space per six residents, plus an additional space for the administrator.
3. Common area shall be provided on the basis of a minimum of 15 square feet per resident.
4. A facility may not be located closer than 660 feet from another Group Residential Care Facility, measured by means of the shortest distance from property line to property line. The provisions of Section 19A.04.040(B) do not apply to this Condition #4. However, a waiver of the distance limitation may be obtained from the City Council, after a recommendation from the Planning Commission, as follows:
 - a. A public hearing must be conducted by both the Planning Commission and City Council, after notice of hearing has been provided as in the case of a Special Use Permit.
 - b. The applicant must demonstrate to the satisfaction of the City Council that approval of the waiver will not have a detrimental impact on surrounding properties.
 - c. Approval of a waiver may be conditioned upon measures designed to ensure compatibility of the use.
5. The facility must comply on an ongoing basis with all governmental licensing requirements.
6. Conditions 1-4 shall not apply to the first Group Residential Care Facility to locate

1 within any particular neighborhood. Such facility shall be treated as a single family dwelling.

2 SECTION 6: Section 19A.04.050(B) of the Zoning Code of the City of Las Vegas is hereby
3 amended by adding thereto, in its corresponding location, a new subsection entitled
4 "TRANSITIONAL LIVING GROUP HOME," reading as follows:

5 **TRANSITIONAL LIVING GROUP HOME [U, R-A, R-E, R-D, R-1, R-CL, R-2, R-3, R-4, R-5]**

- 6 1. The home must be located on a parcel with a minimum size of 6,500 square feet.
- 7 2. Off-street parking shall be provided on the basis of at least one space per six residents,
8 plus an additional space for the administrator.
- 9 3. Common area shall be provided on the basis of a minimum of 15 square feet per
10 resident.
- 11 4. The facility must comply on an ongoing basis with all governmental licensing
12 requirements.

13 SECTION 7: Subchapter 19A.20.020 of the Zoning Code of the City of Las Vegas is hereby
14 amended by deleting therefrom the terms "Residential Care Facility" and "Family Group Home,"
15 along with their corresponding definitions.

16 SECTION 8: Subchapter 19A.20.020 of the Zoning Code of the City of Las Vegas is hereby
17 amended by adding thereto, in the corresponding locations, the following terms and their respective
18 definitions:

19 **Group Residential Care Facility.** A dwelling of a residential character which is used or intended
20 to be used to provide housing and care for up to ten elderly persons or persons with a handicap. The
21 term does not include an individual residential care facility, convalescent care facility, nursing home,
22 hospital, special care facility or any facility which:

- 23 1. provides surgical, medical, psychiatric or other specialized treatment on a regular basis;
- 24 2. provides housing and care to persons who have a chronic illness, disease, injury or
25 other medical condition; or
- 26 3. provides housing, care or treatment to persons whose occupancy would constitute a
27 direct threat to the health or safety of other individuals or their property.

28 **Individual Residential Care Facility.** A home in which a natural person furnishes food, shelter,

1 assistance and limited supervision, for compensation, to not more than two persons who are aged,
2 infirm, mentally retarded or handicapped, unless the persons receiving those services are related
3 within the third degree of consanguinity or affinity to the person providing those services.

4 **Transitional Living Group Home.** A dwelling of a residential character which is operated under an
5 appropriate State or County license and which provides housing and related assistance for six or fewer
6 persons who are in need of transitional living arrangements. The term does not include an individual
7 residential care facility, group residential care facility, convalescent care facility, nursing home,
8 hospital, special care facility or any facility which:

- 9 1. provides surgical, medical, psychiatric or other specialized treatment on a regular basis;
- 10 2. provides housing and care to persons who have a chronic illness, disease, injury or other
11 medical condition; or
- 12 3. provides housing, care or treatment to persons whose occupancy would constitute a direct
13 threat to the health or safety of other individuals or their property.

14 SECTION 9: If any section, subsection, subdivision, paragraph, sentence, clause or
15 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
16 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
17 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
18 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
19 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
20 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
21 invalid or ineffective.

22 SECTION 10: All ordinances or parts of ordinances or sections, subsections, phrases,
23 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,

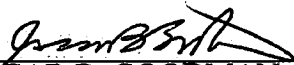

4. A facility may not be located closer than 660 feet from another Group Residential Care Facility (7-10), measured by means of the shortest distance from property line to property line. Group Residential Care Facility (1-6). A dwelling of a residential character which is used or intended to be used to provide housing and care for six or fewer elderly persons or persons with a handicap. The term does not include an individual residential care facility, convalescent care facility, nursing home, hospital, special care facility or any facility which:

a) provides surgical, medical, psychiatric or other specialized treatment on a regular basis;

b) provides housing and care to persons who have a chronic illness, disease, injury or other medical condition; or

c) provides housing, care or treatment to persons whose occupancy would constitute a direct threat to the health or safety of other individuals or their property.

Group Residential Care Facility (7-10). A dwelling of a residential character which is used or intended to be used to provide housing and care for more than six and fewer than eleven elderly persons or persons with a handicap. The term does not include a convalescent care facility, nursing home, hospital, special care facility or any facility which:

a) provides surgical, medical, psychiatric or other specialized treatment on a regular basis;

b) provides housing and care to persons who have a chronic illness, disease, injury or other medical condition; or

c) provides housing, care or treatment to persons whose occupancy would constitute a direct threat to the health or safety of other individuals or their property.

Individual Residential Care Facility. A home in which a natural person furnishes food, shelter, assistance and limited supervision, for compensation, to not more than two persons who are aged, infirm, mentally retarded or handicapped, unless the persons receiving those services are related within the third degree of consanguinity or affinity to the person providing those services.

1 SECTION 6: If any section, subsection, subdivision, paragraph, sentence, clause or
2 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
3 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
4 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
5 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
6 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
7 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
8 invalid or ineffective.

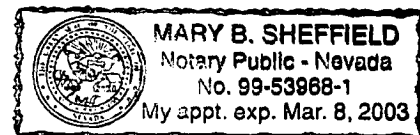
