7 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS
8 FOLLOWS:

9 SECTION 1: Title 2, Chapter 9, of the Municipal Code of the City of Las Vegas, Nevada,
10 1983 Edition, is hereby amended to add a new section, reading as follows:

11 The Department of Neighborhood Services shall consist of the following divisions:

- 12 (A) Administrative Services;
- 13 (B) Neighborhood Development;
- 14 (C) Neighborhood Planning & Support;
- 15 (D) Neighborhood Response.

16 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase
17 in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid or
18 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
19 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of
20 the City of Las Vegas hereby declares that it would have passed each section, subsection,
21 subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or
22 more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared
23 unconstitutional, invalid or ineffective.

24 SECTION 3: All ordinances or parts of ordinances or sections, subsections, phrases,
