AN ORDINANCE TO REPEAL AND REPLACE CHAPTER 2.46 OF THE MUNICIPAL CODE RELATING TO THE SENIOR CITIZENS' ADVISORY BOARD, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Repeals and replaces LVMC
Chapter 2.46 relating to the Senior Citizens'
Advisory Board.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 2, Chapter 46, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby repealed in its entirety.

SECTION 2: Title 2 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new chapter, designated as Chapter 46, consisting of Sections 10 to 50, inclusive, reading as follows:

2.46.010: There is created a Senior Citizens' Advisory Board, whose purpose is to advise and make recommendations to the City Council concerning subjects of particular interest to senior citizens and others who share the same interests as senior citizens. Such subjects include without limitation transportation, housing, utility rates and service, employment and other matters related to the health, safety and welfare of senior citizens. As used in this Chapter, the term "Advisory Board" refers to the Senior Citizens' Advisory Board.

2.46.020: (A) The Advisory Board shall consist of eight members who are appointed by the City Council.

(B) Each member of the Council other than the Mayor is entitled to nominate one person for appointment to the Advisory Board. Each person so nominated must be a resident of the ward represented by the Council member making the nomination.

(C) The Mayor is entitled to nominate two persons for appointment. The persons so nominated must reside in two different wards, but otherwise may be residents of any of the wards of the City.

1 (D) The term of each member of the Advisory Board is coterminous with the term
2 of the member of the City Council who nominated the Advisory Board member for appointment,
3 except that a member may continue to serve until a successor is appointed.

4 (E) No member of the Advisory Board may:

- 5 (1) Serve for an uninterrupted period longer than eight years;
6 (2) Continue to serve after ceasing to reside in the ward from which he or
7 she was appointed, unless that event occurs by reason of the realignment of ward boundaries; or
8 (3) Serve concurrently on any other board or commission which is
9 established by resolution or ordinance, other than one which may be established on a temporary basis
10 only.

11 **2.46.030:** (A) The Advisory Board shall elect from among its members a Chairman and Vice-
12 Chairman, and such other officers as deemed necessary or appropriate. Officers shall serve a term of
13 one year, or until a successor is elected.

14 (B) The Director of the City's Office of Administrative Services, or the Director's
15 designee, shall serve ex-officio to represent the City's interests and to function as liaison between the
16 Advisory Board and the City.

17 **2.46.040:** (A) The Advisory Board shall adopt such bylaws as it deems necessary for the
18 conduct of its business. The bylaws may include procedural rules, the designation of regular meeting
19 dates, and the procedures for calling special meetings.

20 (B) Bylaws, as well as any amendments thereto:

- 21 (1) Must be consistent with this Chapter; and
22 (2) May be adopted only after consideration at two consecutive meetings
23 of the Advisory Board, and only by a two-thirds majority vote of the entire membership.

24 **2.46.050:** The Advisory Board may create such committees and subcommittees as it deems
25 necessary for the conduct of its business.

26 **SECTION 3:** The Senior Citizens' Advisory Board which has functioned under
27 LVMC Chapter 2.46, as repealed by Section 1 of this Ordinance, is discontinued. However, for
28 purposes of making initial appointments to the replacement Advisory Board, the City Council may

1 appoint any person who was serving on the existing Advisory Board without regard to the residency
2 requirements set forth in Section 2.46.020, as adopted in Section 2 of this Ordinance.

3 SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or
4 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
5 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
6 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
7 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
8 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
9 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
10 invalid or ineffective.

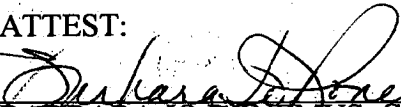
