ORDINANCE NO. 5209

AN ORDINANCE TO AMEND THE MUNICIPAL CODE TO PROHIBIT THE UNAUTHORIZED USE OF THE CITY SEAL OR CITY FLAG, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Sponsored by: Councilman Michael McDonald

Summary: Prohibits the unauthorized use of the City seal and City flag.

**THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:**

SECTION 1: Title 1, Chapter 8, Section 50, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

1.08.050: It is unlawful for any person to use the official seal or the official flag of the City, or any reproduction, facsimile or colorable imitation thereof, [with intent to mislead or defraud.] except:

(A) With the express permission of the City Council;

(B) In the performance of official acts by a department of the City;

(C) On items distributed by a department of the City which are not necessary to carry out the duties of that department, if the use is approved by the department director; or

(D) As otherwise permitted by a specific ordinance.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 3: Whenever in this ordinance any act is prohibited or is made or declared to be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required or the failure to do any act is made or declared to be unlawful or an offense or a

1 misdemeanor, the doing of such prohibited act or the failure to do any such required act shall
2 constitute a misdemeanor and upon conviction thereof, shall be punished by a fine of not more than
3 \$1,000.00 or by imprisonment for a term of not more than six months, or by any combination of such
4 fine and imprisonment. Any day of any violation of this ordinance shall constitute a separate offense.

5 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,
6 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
7 1983 Edition, in conflict herewith are hereby repealed.

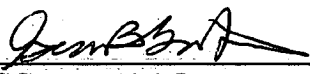

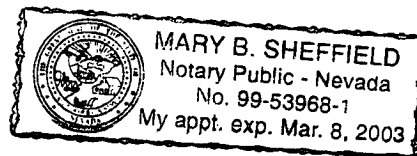

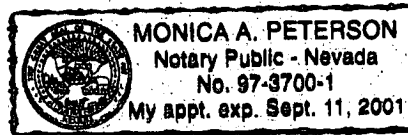
