AN ORDINANCE TO ADJUST THE ZONING CODE REQUIREMENTS FOR OFF-STREET PARKING FOR ELEMENTARY AND JUNIOR HIGH/MIDDLE SCHOOLS, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Adjusts the off-street parking requirements for elementary and junior high/middle schools.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Section 19A.10.010(F) of the Zoning Code of the City of Las Vegas is hereby amended by amending the "Institutional/Community Service" element of Table 1 to delete the rows that pertain to the uses "Public or Private School, Elementary" and "Public or Private School, Junior High" and to add in lieu thereof a row that pertains to the use "Public or Private School, Elementary or Junior High/Middle School." The new row shall read as follows:

INSTITUTIONAL/COMMUNITY SERVICE	
Public or Private School, Elementary or Junior High/Middle School	Two spaces per classroom, plus twenty spaces for administrative staff

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 3: All ordinances or parts of ordinances or sections, subsections, phrases,
