

AN ORDINANCE CREATING A GOLF BOARD FOR THE CITY OF LAS VEGAS, PROVIDING FOR THE APPOINTMENT OF ITS MEMBERS, DEFINING ITS DUTIES AND OTHER MATTERS RELATING THERETO.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

Section 1. A board is hereby created to be known as the Las Vegas Golf Board, hereinafter designated as "The Board"; said Board shall consist of five (5) members, all of whom shall be residents and taxpayers of said City of Las Vegas and shall be appointed by the Board of Commissioners of the City of Las Vegas. The Commissioner of Streets and Public Property of the City of Las Vegas shall be entitled to receive and shall receive notice of all meetings of said Golf Board and shall be entitled to attend such meetings.

Section 2. Of the members of the Board so first appointed one shall be appointed for the term of one (1) year expiring June 30, 1942, one for the term of two (2) years expiring June 30, 1943, one for the term of three (3) years expiring June 30, 1944, one for the term of four (4) years expiring June 30, 1945, and one for the term of five (5) years expiring June 30, 1946. Their successors shall be appointed for the term of five (5) years each. Mr. Lorin Konnow is hereby appointed for the term expiring June 30, 1942; Mr. Luther Horner is hereby appointed for the term expiring June 30, 1945; Mr. A.G. Daugherty is hereby appointed for the term expiring June 30, 1944; Mr. Charles De Armond is hereby appointed for the term expiring June 30, 1945; and Mr. C.W. Woodbury is hereby appointed for the term expiring June 30, 1946. If a vacancy shall occur otherwise than by expiration of a term of an appointee member, it shall be filled by appointment for the unexpired portion of the term. And each year the Board of Commissioners of the City of Las Vegas shall appoint one member to said Golf Board to fill the office of the retiring member whose term expires June 30th of each said year. All members of the Board shall be appointed by the Board of Commissioners of the City of Las Vegas.

Section 3. Upon the final passage and adoption of this Ordinance, the Board shall meet and organize by electing from its membership a chairman and a secretary and such other officers as in the judgement of the Board may be necessary. Said Board shall have the power to adopt, from time to time, such rules and regulations as may be necessary or convenient for the conduct of its business. All members of the Board shall serve as such without compensation.

Section 4. Said Board shall have the power and authority to improve, supervise, maintain and operate within the limit of the means provided for that purpose, the Municipal Golf Course now owned by the City of Las Vegas; and to employ such persons and such help and assistance as said Board may deem necessary in furtherance thereof. Provided, however, that no expense or indebtedness shall be incurred in, about or relating to said Municipal Golf Course without the approval of the Board of Commissioners of the City of Las Vegas first having been obtained. And subject to the consent and approval of said Board of Commissioners of the City of Las Vegas, said Golf Board shall have the power to fix and establish green fees and/or any other charges to be made to the general public for playing upon said Golf Course or for any of the privileges in connection therewith, and to adopt rules and regulations for the operation of said Golf Course and for the enjoyment of any privileges in reference to, and in connection with the same.

1 Section 5. The Golf Board shall, when required by the  
2 Board of Commissioners of the City of Las Vegas and annually in  
3 all events, submit to the Board of Commissioners of the City of  
4 Las Vegas an inventory of equipment and supplies on hand, and a  
5 report generally covering the progress of the activities of the  
6 Board. On or before the first day of February in each year, the  
said Golf Board shall submit to the Board of Commissioners of the  
City of Las Vegas an estimate of the financial requirements for  
the ensuing year, and also an itemized estimate of equipment re-  
quired to conduct and maintain said Municipal Golf Course for the  
ensuing year.

7 Section 6. The City Clerk is hereby authorized to have  
8 this Ordinance published in the Las Vegas Optimist  
9 Weekly newspaper printed and pub-  
10 lished in the City of Las Vegas, Clark County, Nevada, for a  
11 period of two (2) weeks, that is to say, once each week for a  
12 period of two (2) weeks.
