11 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
12 AS FOLLOWS:

13 SECTION 1: Title 2, Chapter 9, Section 10, of the Municipal Code of the City of Las
14 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

15 **2.09.010:** The departments of the City shall consist of the following:

- 16 (A) Building and Safety;
17 (B) City Attorney;
18 (C) Detention and Enforcement;
19 (D) Finance and Business Services;
20 (E) Fire [Services;] and Rescue;
21 (F) Human Resources;
22 (G) Information Technologies;
23 (H) Municipal Court;
24 (I) Neighborhood Services;
25 (J) Leisure Services;
26 (K) Planning and Development;
27 (L) Public Works.

28 SECTION 2: Title 2, Chapter 9, Section 100, of the Municipal Code of the City of

1 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2 **2.09.100:** The Department of Fire [Services] and Rescue shall consist of the following divisions:

- 3 (A) Emergency operations;
- 4 (B) Fire alarm communications;
- 5 (C) Fire prevention;
- 6 (D) Maintenance/supply;
- 7 (E) Training.

8 SECTION 3: Title 2, Chapter 20, of the Municipal Code of the City of Las Vegas,
9 Nevada, 1983 Edition, is hereby amended by adding thereto a new section, reading as follows:

10 (A) To the extent that the Department of Fire and Rescue is authorized by the City
11 Council to provide ambulance transportation service, the Department:

12 (1) Shall provide service at the level of "ALS service," as defined in LVMC
13 6.08.020(A).

14 (2) Is authorized to bill patients at rates which have been established by
15 resolution of the City Council and which are on file in the office of the City Clerk.

16 (B) Nothing in Paragraph (1) of Subsection (A) of this Section shall be construed
17 to create any duty of care or obligation toward, or any cause of action or remedy in favor of, any
18 particular patient or class of patients.

19 SECTION 4: Each reference to the Department of Fire Services or to the Chief of Fire
20 Services in Chapter 2.20, Chapter 6.08, Chapter 9.24, Chapter 9.28, Chapter 10.10, Chapter 10.12,
21 Chapter 16.16, or in any other provision of the Municipal Code of the City of Las Vegas, Nevada,
22 1983 Edition, shall be deemed to refer, respectively, to the Department of Fire and Rescue or to the
23 Chief of Fire and Rescue.

24 SECTION 5: If any section, subsection, subdivision, paragraph, sentence, clause or
25 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
26 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
27 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
28 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,

1 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
2 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
3 invalid or ineffective.

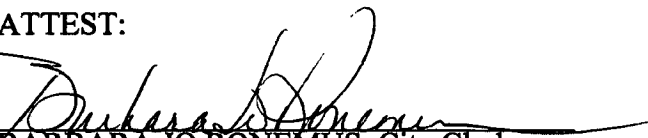
4 SECTION 6: All ordinances or parts of ordinances or sections, subsections, phrases,
5 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
6 1983 Edition, in conflict herewith are hereby repealed.

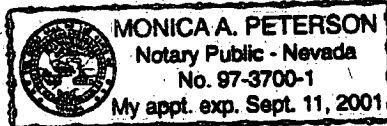

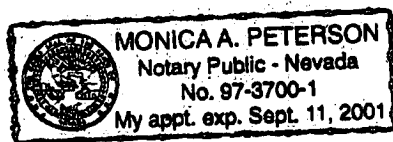
