10 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
11 AS FOLLOWS:

12 SECTION 1: Title 14, Chapter 4, Section 160, of the City of Las Vegas, Nevada,
13 Municipal Code, 1983 Edition, is hereby amended to read as follows:

14 **14.04.160:** In accordance with Section 14.04.130, [There] there is established and imposed upon
15 the customers of the City's sewage disposal system, effective as of [July 1, 1998,] August 1, 1999, a
16 regional surcharge, which is tied to the annual service charge the City is required to pay to the County,
17 in the amount of one dollar and [thirty-nine] sixty cents per equivalent residential unit. Each customer
18 shall pay to the City annually, as his, her or its proportionate share of the service [surcharge] charge
19 due from the City to Clark County pursuant to Clark County Ordinance No. 730, an amount equal to
20 one dollar and [thirty-nine] sixty cents multiplied by the number of equivalent residential units
21 charged to such customer. The surcharge shall be billed annually to each customer of the City's
22 sewage disposal system, including those customers whose properties are hereafter connected thereto,
23 at the same time as the customer's regular sewer service charge and shall apply to the calendar year
24 in which it is billed, [; provided, however, that the] The amount of such surcharge may hereafter be
25 adjusted administratively from time to time to reflect any change effected by Clark County in such
26 service charge pursuant to Section 4(B) to 4(D), inclusive, of Clark County Ordinance No. 730.

27 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or
28 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid

1 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
2 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
3 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
4 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
5 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
6 invalid or ineffective.

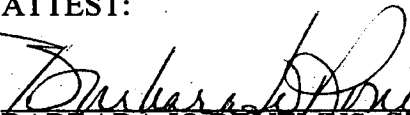
7 SECTION 3: All ordinances or parts of ordinances or sections, subsections, phrases,

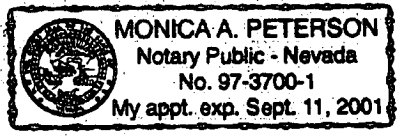
