ORDINANCE NO. 5319

AN ORDINANCE TO REVISE CERTAIN MUNICIPAL CODE PROVISIONS REGARDING THE STOPPING, STANDING AND PARKING OF VEHICLES, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Proposed by: Michael Sheldon,
Director of Detention and Enforcement

Summary: Revises certain Municipal Code provisions regarding the stopping, standing and parking of vehicles.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 11, Chapter 2, Section 60, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11.02.060: "Recreational vehicle" means any vehicle or trailer designed, maintained and used as a travel trailer, camper, motor home, tent trailer, boat, boat trailer, snowmobile, snowmobile trailer, [jet-ski, jet-ski] personal watercraft, personal watercraft trailer, camping trailer or other vehicle of a similar nature.

SECTION 2: Title 11, Chapter 48, Section 90, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11.48.090: No person shall stand or park a vehicle, trailer, or combination of vehicle and trailer which has an overall length greater than twenty-four feet or an unladen weight in excess of eight thousand pounds [unladen weight] in any [residence] residential district, except when actually and expeditiously engaged in the loading or unloading of merchandise or when such vehicle is being used in conjunction with the performance of service, repair, construction or similar essential use within the immediate neighborhood.

SECTION 3: Title 11, Chapter 52, Section 305, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11.52.305: It is unlawful for a person to stand, park or store, [the following upon any street designated by the City Council as a residential street:

(A) A] upon any residential street, a commercial vehicle, recreational vehicle, trailer, or any combination of vehicle and trailer having an overall length of twenty-four feet or more, except

1 in front of the property of the owner or driver thereof, or in front of property from which or to which
2 goods are being picked up or delivered, and in any case for only that period of time during which
3 goods or passengers are being expeditiously loaded or unloaded. [;

4 (B) A commercial vehicle, recreational vehicle, trailer, or any combination of vehicle
5 and trailer, for more than seventy-two consecutive hours in front of the same property; or

6 (C) A commercial vehicle, recreational vehicle, trailer, or any combination of vehicle
7 and trailer in such a manner as to create a hazardous condition for pedestrians or to create a visual
8 obstruction to motorists on a public street.]

9 SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or
10 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
11 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
12 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
13 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
14 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
15 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
16 invalid or ineffective.

17 SECTION 5: All ordinances or parts of ordinances or sections, subsections, phrases,
18 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
19 1983 Edition, in conflict herewith are hereby repealed.

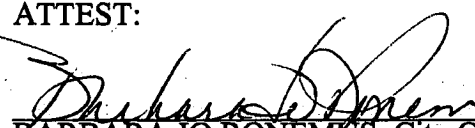

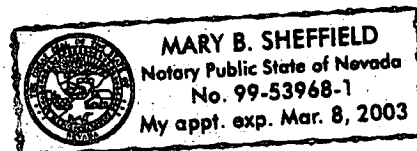

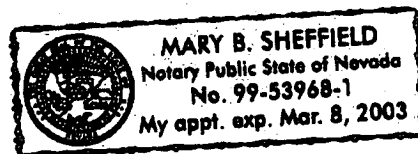
