AN ORDINANCE TO DESIGNATE AS PEACE OFFICERS CERTAIN INVESTIGATORS APPOINTED BY THE CHIEF OF THE DEPARTMENT OF FIRE AND RESCUE, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Designates certain investigators of
the Department of Fire and Rescue as peace
officers.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 2, Chapter 20, Section 40, of the Municipal Code of the City of
Las Vegas, Nevada, 1983 Edition, is hereby repealed in its entirety.

SECTION 2: Title 2, Chapter 20, of the Municipal Code of the City of Las Vegas,
Nevada, 1983 Edition, is hereby amended by adding thereto a new section, designated as Section 40,
reading as follows:

2.20.040: The Chief of the Department of Fire and Rescue may appoint qualified members of his
Department to investigate suspected crimes of arson and other violations of law relating to fire and
environmental safety. Investigators so designated shall be peace officers.

SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or
phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
invalid or ineffective.

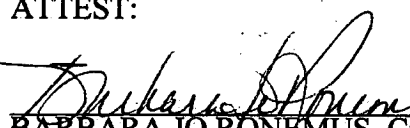

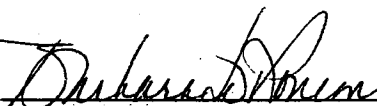

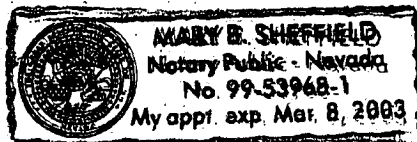
