14 THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA,
15 DOES HEREBY ORDAIN AS FOLLOWS:

16 SECTION 1: The corporate limits of the City of Las
17 Vegas, Nevada, are hereby extended to include, annex to, and make
18 a part of the City of Las Vegas, Nevada, the following described
19 real property, to-wit:

20 The West Half (W 1/2) of the Northwest
21 Quarter (NW 1/4) of the Northwest Quarter
(NW 1/4) of the Southwest Quarter (SW 1/4)
22 of Section 23, Township 20 South, Range
23 60 East, M.D.M., in the County of Clark,
State of Nevada.

24 SECTION 2: That said City Council has determined and
25 does hereby determine, that said described territory meets the
26 requirements provided by law for annexation to the City of Las
27 Vegas for the following reasons:

28 A. The area to be annexed was contiguous to the
29 City's boundaries at the time the annexation pro-
30 ceedings were instituted;

31 B. More than one-eighth (1/8) of the aggregate
32 external boundaries of the area are contiguous to the

1 City of Las Vegas;

2 C. The territory proposed to be annexed is not
3 included within the boundaries of another incor-
4 porated city or within the boundaries of any unin-
5 corporated town as those boundaries existed as of
6 July 1, 1983;

7 D. The City of Las Vegas is eligible to annex the
8 area described in this report since the landowners
9 have signed a petition requesting annexation to
10 the City, said petition constituting one hundred
11 percent (100%) of the owners of record of individual
12 lots or parcels of land within the annexation area.

13 SECTION 3: The City of Las Vegas will provide police
14 protection through the Las Vegas Metropolitan Police Department,
15 fire protection, street maintenance, and library services
16 immediately upon annexation. Garbage collection by the company
17 franchised by the City will also be provided immediately. The
18 City sanitary sewer system will serve the proposed annexation
19 area. Any connection to or extension of this sewer line to serve
20 the annexation area shall be at the expense of the landowners.
21 Other services, such as participation in the City's recreational
22 programs, special educational classes and programs, public works
23 planning, building inspections, and other City Hall services
24 will also be available immediately. Utilities such as gas,
25 electricity, telephone, and water are provided by private utility
26 companies and other services to the area will not be affected by
27 annexation. Street paving, curbs and gutters, sidewalks and
28 street lights which are not in place at the time of annexation
29 will be installed in the presently developed areas upon the
30 request of the property owners and at their expense by means
31 of special assessment districts. Such improvements will be
32 extended into the undeveloped areas as development takes place

1 and the need therefor arises, and will be located according to
2 the needs of the area at that time. Such installations will
3 also be made at the expense of the property owners, either by
4 means of special assessment districts or as prerequisites to the
5 approval of subdivision plats or the issuance of building permits,
6 re-zonings, zone variances or special use permits.

7 SECTION 4: The annexation of said described territory
8 shall become effective on the 10th day of August, 1984, and on
9 such date the City of Las Vegas will have the funds appropriated
10 in sufficient amount to finance the extension into said described
11 territory of police protection, fire protection, street mainte-
12 nance, street sweeping, and street lighting maintenance.

13 SECTION 5: Said described territory, together with the
14 inhabitants and property thereof, shall, from and after the
15 10th day of August, 1984, be subject to all debts, laws, ordinances
16 and regulations in force in the City of Las Vegas and shall be
17 entitled to the same privileges and benefits as other parts of
18 said City, and shall be subject to municipal taxes levied by the
19 City of Las Vegas, Nevada.

20 SECTION 6: The City Engineer of the City of Las Vegas,
21 Nevada, is hereby instructed to cause to be prepared an accurate
22 map or plat of said described territory and to record the same,
23 together with a certified copy of this ordinance in the office of
24 the County Recorder of Clark County, Nevada, which said recording
25 shall be done prior to the 10th day of August, 1984.

26 SECTION 7: If any section, subsection, subdivision,
27 paragraph, sentence, clause or phrase in this Chapter or any
28 part thereof, is for any reason held to be unconstitutional, or
29 invalid or ineffective by any court of competent jurisdiction,
30 such decision shall not affect the validity or effectiveness of
31 the remaining portions of this Chapter or any part thereof. The
32 City Council of the City of Las Vegas hereby declares that it

1 would have passed each section, subsection, subdivision, para-
2 graph, sentence, clause or phrase thereof irrespective of the
3 fact that any one or more sections, subsections, subdivisions,
4 paragraphs, sentences, clauses or phrases be declared unconstitu-
5 tional, invalid or ineffective.

6 SECTION 8: All ordinances or parts of ordinances,
7 sections, subsections, phrases, sentences, clauses or paragraphs
8 contained in the Municipal Code of the City of Las Vegas, Nevada,
9 1983 Edition, in conflict herewith are hereby repealed.

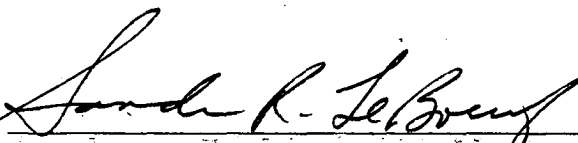

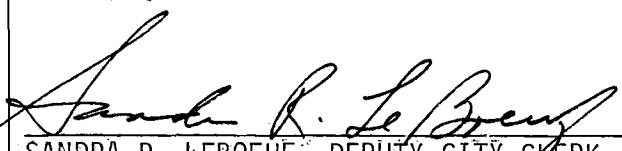
