14 THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA, DOES
15 HEREBY ORDAIN AS FOLLOWS:

16 SECTION 1: Title 10, Chapter 34, Section 10, of the
17 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition,
18 is hereby amended to read as follows:

19 10.34.10: As used in this Chapter, the following words shall have
20 the meaning ascribed to them:

- 21 (A) "House of sadomasochism" means an establishment
22 wherein the practice of flagellation, torture or
23 fettering is used[,] or administered to an
24 individual, either by an employee of the establish-
25 ment or a patron of the establishment.
26 (B) "Nude" means the showing of the human male or
27 female genitals, pubic area or buttocks with less
28 than a full opaque covering, or the showing of the
29 female breast with less than a full opaque covering
30 of any portion thereof below the top of the nipple,
31 or the depiction of covered male genitals in a
32 discernibly turgid state.
(C) "Nude wrestling establishment" means any place of
business wherein any of the participants are engaged
in wrestling as herein defined while in the nude as

1 herein defined and which place reasonably expects
2 to collect any fee, wage, payment, donation,
3 commission or tip as a result of the nude wrestling.

4 (D) "Sadomasochistic abuse" means the practice of
5 using, applying or administering flagellation,
6 torture or fettering to another human being.

7 (E) "Wrestling" means to grapple or engage by physical
8 contact whereby one person seeks to overpower
9 another or throw him or her to the floor or ground.

10 SECTION 2: If any section, subsection, subdivision,
11 paragraph, sentence, clause or phrase in this Chapter or any
12 part thereof, is for any reason held to be unconstitutional or
13 invalid or ineffective by any court of competent jurisdiction,
14 such decision shall not affect the validity or effectiveness of
15 the remaining portions of this Chapter or any part thereof. The
16 City Council of the City of Las Vegas, Nevada, hereby declares
17 that it would have passed each section, subsection, subdivision,
18 paragraph, sentence, clause or phrase thereof, irrespective of
19 the fact that any one or more sections, subsections, subdivisions,
20 paragraphs, sentences, clauses or phrases be declared unconstitu-
21 tional, invalid or ineffective.

22 SECTION 3: All ordinances or parts of ordinances,
23 sections, subsections, phrases, sentences, clauses or paragraphs
24 contained in the Municipal Code of the City of Las Vegas, Nevada,
25 1983 Edition, in conflict herewith are hereby repealed.
