AN ORDINANCE RELATING TO BUSINESS LICENSING LAWS AND REGULATIONS; AMENDING TITLE 6, CHAPTER 6, AND TITLE 6, CHAPTER 86, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1983 EDITION, TO REQUIRE THAT APPLICANTS FOR PRIVILEGED LICENSES, APPROVALS OF SUITABILITY OR WORK CARDS PAY THE FEES NECESSARY FOR INVESTIGATION OF THEIR APPLICATIONS; PROVIDING FOR OTHER MATTERS RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Councilman Al Levy	Requires applicants for privileged licenses, approvals of suitability or work cards to pay the fees necessary for investigation of their applications.

THE CITY COUNCIL OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 6, Chapter 6, Section 100 of the Municipal Code of the City of Las Vegas, 1983 Edition, is hereby amended to read as follows:

6.06.100: Each applicant shall pay to the Department, at the time of filing an application for a license, or an approval for suitability the following nonrefundable investigation fee[s] deposits:

- (A) For a license \$200.00;
- (B) For an approval of suitability \$150.00.

SECTION 2: Title 6, Chapter 6 of the Municipal Code of the City of Las Vegas, 1983 Edition, is hereby amended by adding thereto a new section, designated as Section 105, reading as follows:

6.06.105: (A) Every applicant shall pay the entire cost incurred by the Department or the Metropolitan Police Department to complete the investigations required by this Chapter, whether the application is approved or denied. Such costs are a collectible debt due to the Department and must be paid in full before licensing.

1 (B) The Metropolitan Police Department or other
2 investigative unit performing investigations under
3 this Chapter shall maintain an accounting of all
4 investigative activity for which the applicant
5 will be billed, including the date, the actual
6 hours expended, description of activity, and the
7 name of the investigator(s) performing same. Such
8 investigative records shall be compiled as the
9 activities are performed and shall be promptly
10 made available to the applicant, Department or
11 City Council, upon written request.

12 SECTION 3: Title 6, Chapter 86, Section 70 of the
13 Municipal Code of the City of Las Vegas, 1983 Edition, is hereby
14 amended to read as follows:

15 6.86.070: (A) Each applicant for the issuance of an original
16 work card shall pay a fee of six dollars to the
17 Metropolitan Police Department prior to the card's
18 issuance.

19 (B) In addition to the fee specified in Subsection (A),
20 each applicant shall pay such other fees as are
21 necessary for the investigation of his or her
22 application. The Metropolitan Police Department
23 shall establish a standard fee deposit for such
24 investigations.

25 [(B)] (C) In the event a work permit is lost or destroyed,
26 the applicant shall pay an additional fee of six
27 dollars for the card's replacement.

28 [(C)] (D) Birthday expiration renewals shall also be six
29 dollars.

30 SECTION 4: Title 6, Chapter 86 of the Municipal Code
31 of the City of Las Vegas, 1983 Edition, is hereby amended by
32 adding thereto a new section, designated as Section 75, reading

as follows:

6.86.075: (A) Every applicant shall pay the entire cost incurred by the Metropolitan Police Department to complete the investigation of an application for a work card, whether the application is approved or denied. Such costs are a collectible debt due to the Metropolitan Police Department and must be paid in full before issuance of a work card.

(B) The Metropolitan Police Department or other investigative unit performing investigations under this Chapter shall maintain an accounting of all investigative activity for which the applicant will be billed, including the date, the actual hours expended, description of activity, and the name of the investigator(s) performing same. Such investigative records shall be compiled as the activities are performed and shall be promptly made available to the applicant, Department or City Council, upon written request.

SECTION 5: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

2 sections, subsections, phrases, sentences, clauses or paragraphs
3 contained in the Municipal Code of the City of Las Vegas, Nevada,
4 1983 Edition, in conflict herewith are hereby repealed.

21 paragraph, sentence, clause or phrase in this ordinance or any
22 part thereof, is for any reason held to be unconstitutional or
23 invalid or ineffective by any court of competent jurisdiction,
24 such decision shall not affect the validity or effectiveness of
25 the remaining portions of this ordinance or any part thereof.
26 The City Council of the City of Las Vegas, Nevada, hereby declares
27 that it would have passed each section, subsection, subdivision,
28 paragraph, sentence, clause or phrase thereof irrespective of
29 the fact that any one or more sections, subsections, subdivisions,
30 paragraphs, sentences, clauses or phrases be declared unconstitu-
31 tional, invalid or ineffective.

SECTION 6: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, in conflict herewith are hereby repealed.

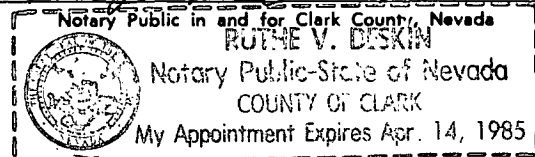
