ORDINANCE No. 3160

AN ORDINANCE RELATING TO THE LAS VEGAS MUNICIPAL COURT; AMENDING TITLE 2, CHAPTER 26, SECTION 30, OF THE MUNICIPAL CODE OF THE CITY OF VEGAS, NEVADA, 1983 EDITION, TO INCREASE THE SALARY OF THE MUNICIPAL COURT JUDGES; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Increases the salary of

THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA DOES  
HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 2, Chapter 26, Section 30, of the  
Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is  
hereby amended to read as follows:

2.26.030: (A) Except as provided in Subsections (B) and (C)  
of this Section, the salaries of the Municipal Court Judges  
shall each be [twenty-six thousand] thirty-seven thousand  
five hundred dollars per year.

(B) The salaries of the Municipal Court Judges of  
Departments 2 and 3 shall each be [thirty-seven] forty-seven  
thousand five hundred dollars per year beginning with the  
term of office following the primary and general elections of  
May and June, [1981.] 1985.

(C) The salaries of the Municipal Court Judges of  
Departments 1 and 4 shall each be [thirty-seven] forty-seven  
thousand five hundred dollars per year beginning with the  
term of office following the primary and general elections of  
May and June, [1983.] 1987.

SECTION 2: If any section, subsection, subdivision,  
paragraph, sentence, clause or phrase in this Chapter or any part  
thereof, is for any reason held to be unconstitutional or invalid  
or ineffective by any court of competent jurisdiction, such deci-  
sion shall not affect the validity or effectiveness of the

1 remaining portions of this Chapter or any part thereof. The City  
2 Council of the City of Las Vegas, Nevada, hereby declares that it  
3 would have passed each section, subsection, subdivision,  
4 paragraph, sentence, clause or phrase thereof, irrespective of  
5 the fact that any one or more sections, subsections, sub-  
6 divisions, paragraphs, sentences, clauses or phrases be declared  
7 unconstitutional, invalid or ineffective.

8 SECTION 3: All ordinances or parts of ordinances,  
9 sections, subsections, phrases, sentences, clauses or paragraphs  
10 contained in the Municipal Code of the City of Las Vegas, Nevada,  
11 1983 Edition, in conflict herewith are hereby repealed.

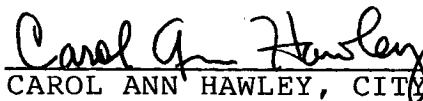
