15 SECTION 1: Title IX, Chapter 5 of the Municipal Code
16 of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed
17 in its entirety.

18 SECTION 2: Title IX, Chapter 6 of the Municipal Code
19 of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed
20 in its entirety.

21 SECTION 3: Title IX, Chapter 7 of the Municipal Code
22 of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed
23 in its entirety.

24 SECTION 4: Title IX, Chapter 9 of the Municipal Code
25 of the City of Las Vegas, Nevada, 1960 Edition, is hereby repealed
26 in its entirety.

27 SECTION 5: If any section, subsection, subdivision,
28 paragraph, sentence, clause or phrase in this Chapter or any
29 part thereof, is for any reason held to be unconstitutional, or
30 invalid or ineffective by any court of competent jurisdiction,
31 such decision shall not affect the validity or effectiveness of
32 the remaining portions of this Chapter or any part thereof. The
Board of Commissioners of the City of Las Vegas hereby declares

1 that it would have passed each section, subsection, subdivision,
2 paragraph, sentence, clause or phrase thereof irrespective of
3 the fact that any one or more sections, subsections, subdivisions,
4 paragraphs, sentences, clauses or phrases be declared unconstitu-
5 tional, invalid or ineffective.

6 SECTION 6: All ordinances or parts of ordinances,
7 sections, subsections, phrases, sentences, clauses or paragraphs
8 contained in the Municipal Code of the City of Las Vegas, Nevada,
9 1960 Edition, in conflict herewith are hereby repealed.

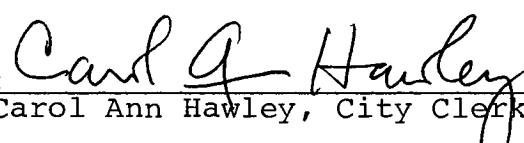
