ORDINANCE NO. 2234

AN ORDINANCE RELATING TO PLUMBING; AMENDING TITLE IV, CHAPTER 2, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY AMENDING SECTION 7 OF THAT CERTAIN DOCUMENT INCORPORATED INTO SAID TITLE AND CHAPTER BY SECTION 1 THEREOF AND ENTITLED "SUPPLEMENTAL DOCUMENT, ADOPTED BY REFERENCE, COMPLETING THE 1979 UNIFORM PLUMBING CODE OF THE CITY OF LAS VEGAS, NEVADA, AND HEREBY DESIGNATED AS PART 2 OF TITLE IV, CHAPTER 2, SECTIONS 1 THROUGH 23, AND ALSO DESIGNATED AS ORDINANCE NO. 2085" BY ADDING TO THE LIST OF SPECIALTY CONTRACTORS TO WHICH PERMITS MAY BE ISSUED TO PERFORM PLUMBING WORK WITHIN THEIR RESPECTIVE SPECIALTIES WHICH IS CONTAINED IN SAID SECTION 7 THE CLASSIFICATION OF SWIMMING POOL CONTRACTOR; AND PROVIDING OTHER MATTERS PROPERLY RELATING THEREOF.

Summary: Adds classification of swimming pool contractor to list of specialty contractors to which permits may be issued to perform plumbing work within their respective specialties.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title IV, Chapter 2, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by amending Section 7 of that certain document incorporated in said Title and Chapter by Section 1 thereof and entitled "Supplemental Document, Adopted By Reference, Completing the 1979 Uniform Plumbing Code of the City of Las Vegas, Nevada, and Hereby Designated as Part 2 of Title IV, Chapter 2, Sections 1 Through 23, and Also Designated as Ordinance No. 2085", by adding thereto a new subsection, to be designated as subsection (G) reading as follows:

(G) 1. A permit may be issued to a swimming pool contractor to do all plumbing or drainage work, both existing and new, directly related to swimming pool work. This plumbing work shall be limited to:

(a) Gas line installation from the source of supply to the pool heater within a closed system. The swimming pool contractor shall not connect

1 the gas piping to the source of supply. The
2 gas line installation shall conform to the
3 requirements of the Uniform Plumbing Code.

4 (b) Only one cut into the existing water line with
5 an approved connection for the purpose of filling
6 the pool or spa (as per Uniform Plumbing Code).

7 (c) Only one connection to the existing drainage
8 system for the waste disposal of the pool or spa
9 only (as per Uniform Plumbing Code).

10 2. For the purposes of this Section, a swimming pool
11 contractor is a contractor who holds a current A-10
12 Swimming Pool Contractor License or a current C-40
13 Swimming Pool Piping Contractor License issued by the
14 State of Nevada.

15 SECTION 2: If any section, subsection, subdivision,
16 paragraph, sentence, clause or phrase in this Chapter or any
17 part thereof, is for any reason held to be unconstitutional, or
18 invalid or ineffective by any court of competent jurisdiction,
19 such decision shall not affect the validity or effectiveness of
20 the remaining portions of this Chapter or any part thereof. The
21 Board of Commissioners of the City of Las Vegas hereby declares
22 that it would have passed each section, subsection, subdivision,
23 paragraph, sentence, clause or phrase thereof irrespective of
24 the fact that any one or more sections, subsections, subdivisions,
25 paragraphs, sentences, clauses or phrases be declared unconstitu-
26 tional, invalid or ineffective.

27 SECTION 3: All ordinances or parts of ordinances,
28 sections, subsections, phrases, sentences, clauses or paragraphs
