

AN ORDINANCE TO AMEND MAJOR STREET PLAN MAP ADOPTED BY ORDINANCE 1537 ON OCTOBER 6, 1971, BY DELETING THEREFROM PEAK DRIVE FROM JONES BOULEVARD TO RANCHO DRIVE; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1: The Major Street Plan of the City of Las Vegas, adopted by Ordinance No. 1537 on October 6, 1971, is hereby amended to delete Peak Drive from Jones Boulevard to Rancho Drive.

SECTION 2: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

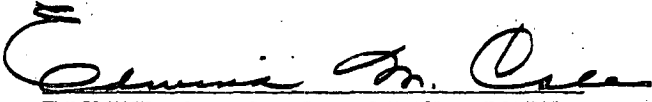

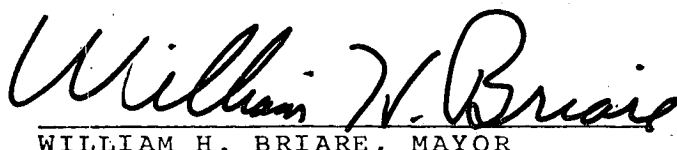
