

ORDINANCE NO. 1826

AN ORDINANCE TO AMEND TITLE X, CHAPTER 17, SECTION 33, SUBSECTION C OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, 1960 EDITION, BY PROVIDING FOR IMMOBILIZATION OF VEHICLES ON CITY-OWNED OR CITY-LEASED PARKING LOTS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA,
DOES ORDAIN AS FOLLOWS:

SECTION 1: Title X, Chapter 17, Section 33, Subsection C of the Municipal Code of the City of Las Vegas, 1960 Edition, is hereby amended by providing for immobilization of vehicles on City-owned or City-leased parking lots and is to read as follows:

10-17-33 (C) The City Manager or his duly authorized representative shall have the authority to immobilize any vehicle or have any vehicle removed by towing and impounding from a City-owned or City-leased parking lot if such vehicle is found to be in violation of this Section. All expenses incurred in the immobilization or towing and impounding of such vehicle found to be in violation shall be the responsibility of and charged to the registered owner of said vehicle.


SECTION 2: All ordinances or parts of ordinances, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

SECTION 3: If any section, paragraph, sentence, phrase, term, word, or connotation of this ordinance, or portion thereof, is for any reason held invalid, inapplicable, or unconstitutional by any Court of competent jurisdiction, such holding shall not invalidate the remaining portions of this ordinance.

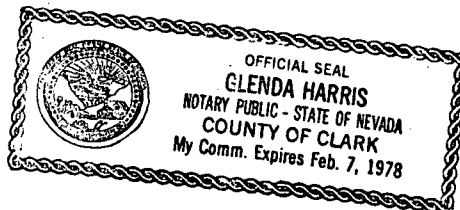

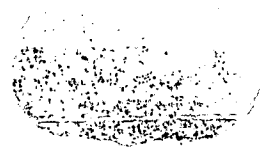
