

ORDINANCE NO. 1383

AN ORDINANCE TO AMEND TITLE V, CHAPTER 18, SECTION 12 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY ADDING A NEW SUBSECTION ENTITLED SUBSECTION (D) "LIQUOR CONTROL," PROVIDING FOR AN ANNUAL MORATORIUM ON ANY OR ALL LIQUOR LICENSES WITHIN THE CITY OF LAS VEGAS, NEVADA; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Title V, Chapter 18, Section 12 of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding thereto a new subsection designated Subsection (D), to read as follows:

5-18-12 (D) LIQUOR CONTROL. The Board of Commissioners may declare an annual moratorium by resolution on any or all liquor and/or beverage applications or licenses if, in its discretion, it is found to be in the interests of the public health, safety, welfare and morals of the residents of the city.

SECTION 2. All ordinances or parts of ordinances, sections, subsections, phrases, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.

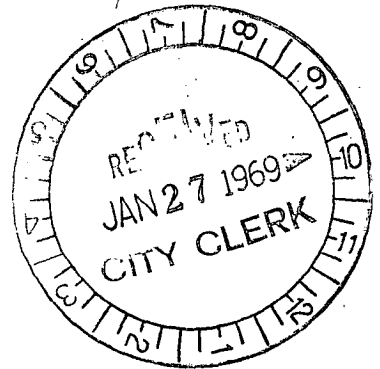
