ORDINANCE NO. 2079

AN ORDINANCE TO RE-ADOPT TITLE VI, CHAPTER 1, SECTION 34, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, PROVIDING THAT AN OFFENSE MADE A MISDEMEANOR BY THE LAWS OF THE STATE OF NEVADA SHALL ALSO BE A MISDEMEANOR IN THE CITY OF LAS VEGAS WHENEVER SUCH OFFENSE IS COMMITTED WITHIN THE BOUNDARIES OF SAID CITY.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA DOES HEREBY ORDAIN AS FOLLOWS:

WHEREAS, the Legislature of the State of Nevada, by virtue of the Las Vegas City Charter, has granted to the Board of Commissioners of said City the power to declare by ordinance that any offense made a misdemeanor by the laws of the State of Nevada shall also be deemed to be a misdemeanor in the City of Las Vegas whenever such offense is committed within the boundaries of said City; and

WHEREAS, the Board of Commissioners of said City has exercised such power, the ordinance to be found in Title VI, Chapter 1, Section 34 of the Municipal Code of said City; and

WHEREAS, many new criminal laws were enacted by the 1979 Session of the Nevada Legislature, which laws became effective on passage, some on July 1, 1979, and some on January 1, 1980; and

WHEREAS, the Board of Commissioners of said City desires by this ordinance to re-adopt said Title VI, Chapter 1, Section 34 to include within its purview all of the state misdemeanor laws which are now in effect.

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES ORDAIN AS FOLLOWS:

1 SECTION 1: Title VI, Chapter 1, Section 34, is hereby
2 re-adopted.

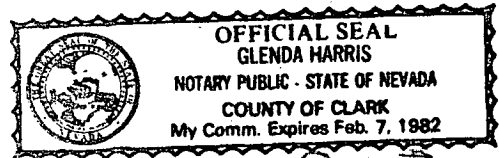

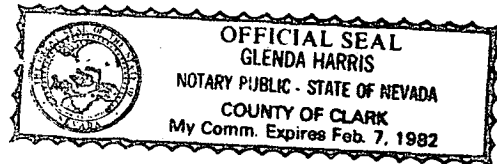

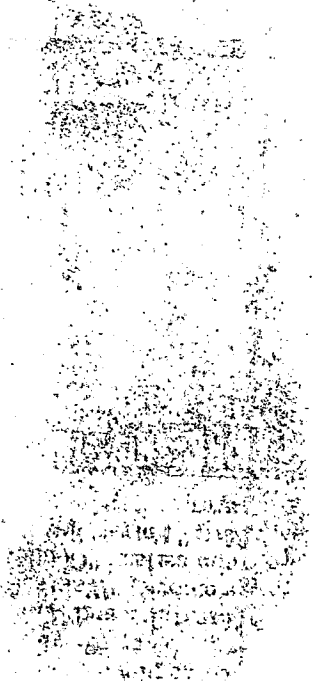
