

ORDINANCE NO. 1870

AN ORDINANCE TO AMEND TITLE I, CHAPTER 5, SECTION 8, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, TO RE-ESTABLISH THE WARD BOUNDARIES OF THE CITY OF LAS VEGAS BASED UPON VOTING PRECINCTS; PROVIDING OTHER MATTERS PROPERLY RELATING THERETO: AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES ORDAIN AS FOLLOWS:

SECTION 1: Title I, Chapter 5, Section 8, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

1-5-8 Division of City into Wards and the Election of City Commissioners therefrom:

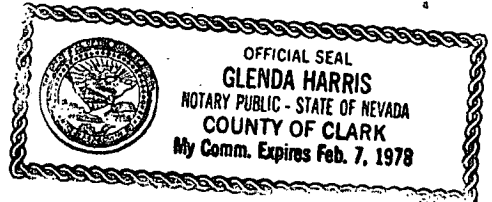
