ORDINANCE 1972

AN ORDINANCE TO AMEND TITLE VI OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY REPEALING THE EXISTING CHAPTER 1, SECTION 11 OF TITLE VI ENTITLED "DISORDERLY PERSONS" IN ITS ENTIRETY; AND BY ADOPTING A NEW CHAPTER 1, SECTION 11 OF TITLE VI ENTITLED "LOITERING FOR THE PURPOSE OF BEGGING".

INTENT OF BILL: An ordinance to amend Title VI of the Municipal Code by repealing Chapter 1, Section 11 in its entirety and adopting a new Chapter 1, Section 11 which will regulate loitering for the purpose of begging by providing a criminal penalty for its violation.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS,
NEVADA DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title VI of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by repealing Chapter 1, Section 11 of Title VI, entitled "Disorderly Persons", in its entirety.

SECTION 2: Title VI of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended by adding a new Chapter 1, Section 11 to Title VI, entitled "Loitering for the Purpose of Begging", and to read as follows:

6-1-11: LOITERING FOR THE PURPOSE OF BEGGING: Any person, except as permitted under Title II, Chapter 7 of the Municipal Code of the City of Las Vegas, who loiters, remains or wanders about in a public place for the purpose of begging shall be guilty of a misdemeanor.



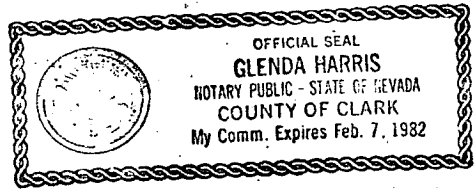

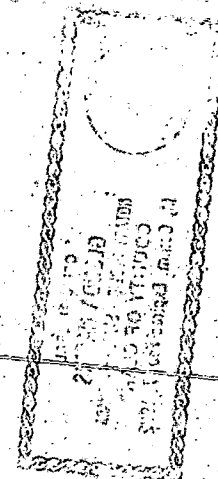
