

ORDINANCE NO. 1791

AN ORDINANCE TO AMEND TITLE I, CHAPTER 5, SECTION 6 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, AND CREATING AN AMENDMENT TO TITLE I, CHAPTER 5, SECTION 6 SETTING THE SECOND REGULARLY HELD MONTHLY MEETING OF THE BOARD OF CITY COMMISSIONERS AT THE EVENING HOUR OF 7:00 P.M., EACH 3RD WEDNESDAY OF EACH MONTH, PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 6 of Chapter 5 of Title I of the Municipal Code of the City of Las Vegas, Nevada 1960 Edition, is hereby amended as follows:

1-5-6 MEETINGS OF BOARD OF COMMISSIONERS: The Board of Commissioners of the City of Las Vegas shall meet in regular session two (2) times monthly, said meetings to be held on the first and third Wednesday in each month. The meeting on the first Wednesday shall be held at 9:00 A.M. and the meeting on the third Wednesday shall be held at [7:30] 7:00 P.M., unless one or more of said regular meetings is cancelled as provided for in Section 1-5-7 hereof provided, in no event shall said Board of Commissioners fail to meet in regular session less than once monthly.

(a) The time for holding of said meetings may be set and changed by Resolution of the Board of Commissioners.

SECTION 2. All ordinances or parts of ordinances, chapters, sections, subsections, phrases, sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, in conflict herewith are hereby repealed.




