THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 2, Chapter 9, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.09.010: The departments of the City shall consist of the following:

- (A) Building and Safety;
- (B) Business Activity;
- (C) City Attorney;
- (D) City Clerk;
- (E) Community Planning and Development;
- (F) Design and Development;
- (G) Detention and Correctional Services;
- (H) Economic and Urban Development;
- (I) Financial Management;
- (J) Fire Services;
- (K) General Services;
- (L) Municipal Court;
- (M) Parks[, Recreation and Senior Citizen] and Leisure Activities;

1 (N) Personnel and Employee Relations;

2 (O) Public Works.

3 SECTION 2: Title 2, Chapter 9, Section 130, of the
4 Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is
5 hereby amended to read as follows:

6 2.09.130: The Department of Parks[, Recreation and Senior
7 Citizen] and Leisure Activities shall consist of the
8 following divisions:

9 (A) Programs and facilities;

10 (B) Cultural affairs;

11 (C) Parks and open spaces;

12 (D) Aquatics;

13 (E) Senior citizens center.

14 SECTION 3: If any section, subsection, subdivision
15 paragraph, sentence, clause or phrase in this ordinance or any
16 part thereof, is for any reason held to be unconstitutional or
17 invalid or ineffective by any court of competent jurisdiction,
18 such decision shall not affect the validity or effectiveness of
19 the remaining portions of this ordinance or any part thereof.
20 The City Council of the City of Las Vegas, Nevada, hereby
21 declares that it would have passed each section, subsection, sub-
22 division, paragraph, sentence, clause or phrase thereof,
23 irrespective of the fact that any one or more sections, subsec-
24 tions, subdivisions, paragraphs, sentences, clauses or phrases be
25 declared unconstitutional, invalid or ineffective.

26 SECTION 4: All ordinances or parts of ordinances, sec-
27 tions, subsections, phrases, sentences, clauses or paragraphs





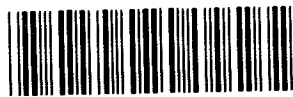
