2 of the Board that he or she actually attends.

3 SECTION 5: Title 19, Chapter 94, of the Municipal  
4 Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby  
5 amended by adding thereto the provision that is set forth as Sec-  
6 tion 6 of this Ordinance.

7 SECTION 6: Each member of the Board of Zoning  
8 Adjustment shall receive from the City, as and for compensation  
9 for his or her services thereon, the sum of \$50.00 for each  
10 meeting of the Board that he or she actually attends.

11 SECTION 7: If any section, subsection, subdivision,  
12 paragraph, sentence, clause or phrase in this ordinance or any  
13 part thereof, is for any reason held to be unconstitutional or  
14 invalid or ineffective by any court of competent jurisdiction,  
15 such decision shall not affect the validity or effectiveness of  
16 the remaining portions of this ordinance or any part thereof.

18 declares that it would have passed each section, subsection, sub-  
19 division, paragraph, sentence, clause or phrase thereof irrespec-  
20 tive of the fact that any one or more sections, subsections, sub-

22 unconstitutional, invalid or ineffective.

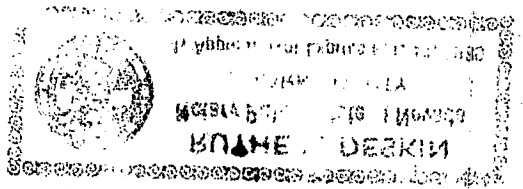
