10 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY
11 ORDAIN AS FOLLOWS:

12 SECTION 1: The Master Plan of Streets and Highways
13 provided for in Title 13, Chapter 12, Section 30 of the Municipal
14 Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby
15 amended by deleting the following:

- 16 A) Cimarron Road, an 80-foot right-of-way, between Ann Road
17 and Washburn Road;
18 B) Buffalo Drive, a 100-foot right-of-way, between Ann Road
19 and Washburn Road;
20 C) Tenaya Way, an 80-foot right-of-way, between Washburn
21 Road and Lone Mountain Road; and
22 D) Washburn Road, an 80-foot right-of-way, between Durango
23 Drive and Tenaya Way.

24 SECTION 2: If any section, subsection, subdivision,
25 paragraph, sentence, clause or phrase in this ordinance or any
26 part thereof, is for any reason held to be unconstitutional or
27 invalid or ineffective by any court of competent jurisdiction,
28 such decision shall not affect the validity or effectiveness of
29 the remaining portions of this ordinance or any part thereof.
30 The City Council of the City of Las Vegas, Nevada, hereby
31 declares that it would have passed each section, subsection, sub-
32 division, paragraph, sentence, clause or phrase thereof irrespec-

1 tive of the fact that any one or more sections, subsections, sub-
2 divisions, paragraphs, sentences, clauses or phrases be declared
3 unconstitutional, invalid or ineffective.

4 SECTION 3: All ordinances or parts of ordinances,
5 sections, subsections, phrases, sentences, clauses or paragraphs
6 contained in the Municipal Code of the City of Las Vegas, Nevada,
7 1983 Edition, in conflict herewith are hereby repealed.
