15 SECTION 1: The Master Plan of Streets and Highways  
16 provided for in Title 13, Chapter 12, Section 30 of the Municipal  
17 Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby  
18 amended as follows:

19 Buffalo Drive south of Cheyenne Avenue is reduced in width  
20 from 150 feet to 100 feet in accordance with Engineering  
21 Drawing No. 115-383.

22 SECTION 2: The Master Plan of Streets and Highways  
23 provided for in Title 13, Chapter 12, Section 30 of the Municipal  
24 Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby  
25 amended as follows:

26 Engineering Drawing No. 115-383, on file in the Department of  
27 Public Works, is hereby adopted.

28 SECTION 3: If any section, subsection, subdivision,  
29 paragraph, sentence, clause or phrase in this ordinance or any  
30 part thereof, is for any reason held to be unconstitutional or  
31 invalid or ineffective by any court of competent jurisdiction,  
32 such decision shall not affect the validity or effectiveness of  
the remaining portions of this ordinance or any part thereof.

1 The City Council of the City of Las Vegas, Nevada, hereby  
2 declares that it would have passed each section, subsection, sub-  
3 division, paragraph, sentence, clause or phrase thereof irrespec-  
4 tive of the fact that any one or more sections, subsections, sub-  
5 divisions, paragraphs, sentences, clauses or phrases be declared  
6 unconstitutional, invalid or ineffective.

7 SECTION 4: All ordinances or parts of ordinances,  
8 sections, subsections, phrases, sentences, clauses or paragraphs  
9 contained in the Municipal Code of the City of Las Vegas, Nevada,  
10 1983 Edition, in conflict herewith are hereby repealed.


