AN ORDINANCE RELATING TO THE SALARIES OF ELECTED OFFICIALS; AMENDING TITLE 2, CHAPTER 2, SECTION 70, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO PROVIDE FOR AN INCREASE IN THE SALARY OF EACH MEMBER OF THE CITY COUNCIL AND THE DATES ON WHICH SUCH INCREASE IN SALARY SHALL BECOME EFFECTIVE; ADDING TO SAID TITLE AND CHAPTER A NEW SECTION, DESIGNATED AS SECTION 80, TO PROVIDE FOR SUBSEQUENT AUTOMATIC ANNUAL INCREASES IN THE SALARY OF EACH MEMBER OF THE CITY COUNCIL; AMENDING CHAPTER 4, SECTION 20, OF SAID TITLE TO PROVIDE FOR AN INCREASE IN THE SALARY OF THE MAYOR AND TO PROVIDE THE DATE ON WHICH SUCH INCREASE IN SALARY SHALL BECOME EFFECTIVE; ADDING TO SAID TITLE AND CHAPTER A NEW SECTION, DESIGNATED AS SECTION 30, TO PROVIDE FOR SUBSEQUENT AUTOMATIC ANNUAL INCREASES IN THE SALARY OF THE MAYOR; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 2, Chapter 2, Section 70, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.02.070: (A) [The] Except as is otherwise provided in subsections (B) and (C) of this Section and LVMC §2.02.080, the salary of each member of the City Council is fifteen thousand dollars per year.

(B) The salaries of the members of the City Council from Wards 1 and 3 shall each be twenty-five thousand five hundred dollars per year beginning with the term of office that commences following the primary and general elections that will be held in May and June of 1987.

1 (C) The salaries of the members of the City Council
2 from Wards 2 and 4 shall each be twenty-five
3 thousand five hundred dollars per year beginning
4 with the term of office that commences following
5 the primary and general elections that will be held
6 in May and June of 1989.

7 SECTION 2: Title 2, Chapter 2, of the Municipal Code
8 of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended
9 by adding thereto a new section, to be designated as Section 80,
10 reading as follows:

11 2.02.080: (A) The salaries of the members of the City Council
12 that are provided for in subsection (B) of LVMC
13 §2.02.070 shall automatically be increased:

14 (1) On the first day of July, 1988, in the
15 same proportion that the index figure of
16 the National Consumer Price Index for All
17 Urban Consumers for All Items, U.S. City
18 Average (1967 = 100) that is published by
19 the Bureau of Labor Statistics, United States
20 Department of Labor, for March of 1988,
21 has increased above such index figure for
22 March of 1987; and

23 (2) On the first day of July in each year there-
24 after, in the same proportion that such index
25 figure for March of that year has increased
26 above such index figure for April of the
27 previous year.

28 (B) The salaries of the members of the City Council
29 that are provided for in subsection (C) of LVMC
30 §2.02.070 shall automatically be increased:

for in paragraph (1) of subsection (A) of this Section and then further increased in the same proportion that the index figure of the National Consumer Price Index for All Urban Consumers for All Items, U.S. City Average (1967 = 100) that is published by the Bureau of Labor Statistics, United States Department of Labor, for March of 1989 has increased above such index figure for March of 1988; and

(2) On the first day of July in each year thereafter, in the same proportion that such index figure for March of that year has increased above such index figure for March of the previous year.

SECTION 3: Title 2, Chapter 4, Section 20, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.04.020: (A) [The] Except as is otherwise provided in subsection (B) of this Section and LVMC §2.04.030, the salary of the Mayor is twenty-four thousand five hundred dollars per year.

(B) The salary of the Mayor shall be thirty-three thousand five hundred dollars per year beginning with the term of office that commences following the primary and general elections that will be held in May and June of 1987.

SECTION 4: Title 2, Chapter 4, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new section, to be designated as Section 30, reading as follows:

2.04.030: The salary of the Mayor that is provided for in

subsection (B) of LVMC §2.04.020 shall automatically be increased:

(A) On the first day of July, 1988, in the same proportion that the index figure of the National Consumer Price Index for all Urban Consumers for All Items, U.S. City Average (1967 = 100) that is published by the Bureau of Labor Statistics, United States Department of Labor, for March of 1988, has increased above such index figure for March of 1987; and

(B) On the first day of July in each year thereafter, in the same proportion that such index figure for March of that year has increased above such index figure for March of the Previous year.

SECTION 5: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

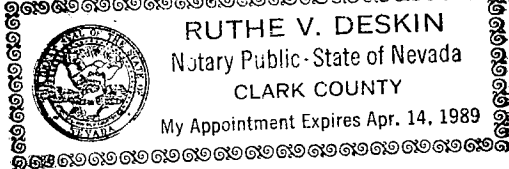
