9 THE CITY COUNCIL OF THE CITY OF LAS VEGAS, DOES HEREBY
10 ORDAIN AS FOLLOWS:

11 SECTION 1: Title 10, Chapter 73, Section of the Municipal Code of the City of
12 Las Vegas, Nevada, 1983 Edition, is hereby extended for a period of one year, and shall remain
13 effective until July 5, 1996, unless it has been subsequently extended by an enactment of the Las
14 Vegas City Council.

15 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause
16 or phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or
17 invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
18 validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City
19 Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section,
20 subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that
21 any one or more section, subsection, subdivision, paragraph, sentence, clause or phrase be
22 declared unconstitutional, invalid or ineffective.

23 SECTION 3: All ordinances or parts of ordinances, sections, subsections, phrases,
24 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas,

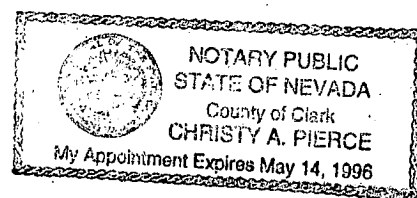
