13 THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS,
14 NEVADA DOES HEREBY ORDAIN AS FOLLOWS:

15 SECTION 1: Title I of the Municipal Code of the City
16 of Las Vegas, Nevada, 1960 Edition, is hereby amended by repealing
17 Chapter 19 of Title I in its entirety.

18 SECTION 2: Title I of the Municipal Code of the City
19 of Las Vegas, Nevada, 1960 Edition, is hereby amended by enacting
20 a new Chapter 19 to read as follows:

21 1-19-1: As used in this chapter "commission or board" means
22 any administrative commission or board established by
23 the Board of City Commissioners and described in Title II of
24 this Code.

25 1-19-2: A member of a commission or board is guilty of neglect
26 of duty if the member receives notice of meetings and
27 without excuse:

28 (a) Fails to attend at least 75% of the meetings
29 held within the previous 24 months, or

30 (b) Misses three consecutive meetings.

31 1-19-3: If it appears a member has neglected his duty to
32 attend commission or board meetings or committed an act

1 of malfeasance or misconduct, the Board of City Commissioners shall
2 notify such member to appear at the next regularly scheduled
3 meeting of said Board and show cause why he should not be removed
4 from office. If, after a hearing, the Board of City Commissioners
5 determines such member is guilty of neglect, the member shall
6 be removed, and a new member shall be appointed to serve out the
7 unexpired term of the former member.

8 1-19-4: The actions of commissions and boards of the City shall
9 be recorded in minute form and filed with the City Clerk
10 within ten (10) days after the meeting.

11 SECTION 3: If any section, subsection, subdivision,
12 paragraph, sentence, clause or phrase in this Chapter or any
13 part thereof, is for any reason held to be unconstitutional, or
14 invalid or ineffective by any court of competent jurisdiction,
15 such decision shall not affect the validity or effectiveness of
16 the remaining portions of this Chapter or any part thereof. The
17 Board of Commissioners of the City of Las Vegas hereby declares
18 that it would have passed each section, subsection, subdivision,
19 paragraph, sentence, clause or phrase thereof irrespective of
20 the fact that any one or more sections, subsections, subdivisions,
21 paragraphs, sentences, clauses or phrases be declared unconstitu-
22 tional, invalid or ineffective.

23 SECTION 4: All ordinances or parts of ordinances,
24 sections, subsections, phrases, sentences, clauses or paragraphs

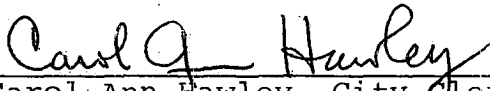
