6 ITY OF AN EX-OFFICIO MEMBER OF THE TRAFFIC AND PARKING COMMISSION
7 TO DESIGNATE A REPRESENTATIVE TO ATTEND A MEETING IN THE MEMBER'S
8 PLACE; TO PROVIDE FOR OTHER MATTERS PROPERLY RELATING THERETO;
9 AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT
10 HEREWITH.

Summary: Clarifies the authority of
an ex-officio member of the Traffic
and Parking Commission to designate
a representative to attend a meeting
in his place.

13 THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS,
14 NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

15 SECTION 1: Title II, Chapter 9 of the Municipal Code of
16 the City of Las Vegas, Nevada, 1960 Edition, is hereby amended
17 to read as follows:

18 2-9-1: There is hereby created and established the Traffic and
19 Parking Commission of the City to serve without compen-
20 sation, consisting of:

21 (A) The [Chief of Police.] The Sheriff or a designated represen-
22 tative from his department.

23 (B) The Director of Public [Works.] Services or a designated
24 representative from his department.

25 (C) The City Attorney or [a member of the legal department] a
26 designated [by him as his] representative from his department.

27 (D) The Fire Chief or a designated representative from his
28 department.

29 (E) The Director of Community Planning and Development or a
30 designated representative from his department.

31 (F) The Traffic Engineer or a designated representative from his
32 division.

(G) Three (3) members of the general public[, all of whom shall
be ex-officio members and entitled to vote. The representatives

1 of the general public shall be] appointed by the Mayor and
2 confirmed by the Board of Commissioners.

3 2-9-2: The term of each appointed member shall be four (4)
4 years, or until his successor takes office.

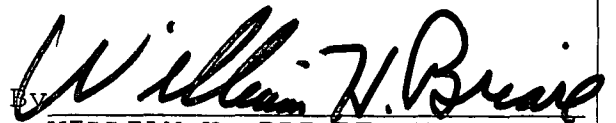
5 2-9-3: Members may be removed after public hearing, by a
6 majority vote of the Board of Commissioners for
7 inefficiency, neglect of duty, or malfeasance of office.

8 SECTION 2: If any section, subsection, subdivision,
9 paragraph, sentence, clause or phrase in this Chapter or any
10 part thereof, is for any reason held to be unconstitutional, or
11 invalid or ineffective by any court of competent jurisdiction,
12 such decision shall not affect the validity or effectiveness of
13 the remaining portions of this Chapter or any part thereof. The
14 Board of Commissioners of the City of Las Vegas hereby declares
15 that it would have passed each section, subsection, subdivision,
16 paragraph, sentence, clause or phrase thereof irrespective of
17 the fact that any one or more sections, subsections, subdivisions,
18 paragraphs, sentences, clauses or phrases be declared unconstitu-
19 tional, invalid or ineffective.

20 SECTION 3: All ordinances or parts of ordinances,
21 sections, subsections, phrases, sentences, clauses or paragraphs
22 contained in the Municipal Code of the City of Las Vegas, Nevada,
23 1960 Edition, in conflict herewith are hereby repealed.

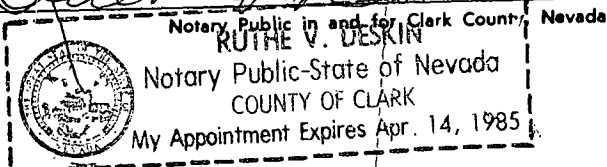
