6 METHOD OF REMOVAL OF PARK AND RECREATION ADVISORY COMMISSION
7 MEMBERS, AND PROVIDING FOR AN UPDATING OF THE DUTIES OF THE
8 COMMISSION; TO PROVIDE FOR OTHER MATTERS PROPERLY RELATING THERETO;
9 AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT
10 HEREWITH.

Summary: Provides for removal of
and updates the duties of members
of the Parks and Recreation Advisory
Commission.

11 THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS,
12 NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

13 SECTION 1: Title II, Chapter 11 of the Municipal Code
14 of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended
15 to read as follows:

16 2-11-1: There is hereby created a Parks and Recreation Advisory
17 Commission consisting of eleven (11) members.

18 The Parks and Recreation Advisory Commission shall be appointed
19 as follows:

20 (A) All members shall be appointed by the City Commission.

21 (B) Members of the Commission shall serve for a period of three
22 (3) years.

23 (C) Vacancies in said Commission, occurring by something other
24 than expiration of term, shall be filled by appointment by
25 the Board of City Commissioners for the remainder of the
26 term. The Parks and Recreation Advisory Commission may
27 submit to the City Commission their recommendations for
28 appointments and re-appointments to the Advisory Commission.

29 2-11-2: The officers of the Commission shall be a chairman,
30 a vice chairman and a secretary. Within fifteen (15)
31 days after the appointment of the Commission, the members shall
32 meet in regular session and select from their members the chairman

1 and the vice chairman. The secretary shall be the Director of
2 Recreation and Leisure Activities of the City, but shall have no
3 vote on the Commission. The duties of the officers of the Commis-
4 sion shall respectively be as are usually carried by such officers.
5 The officers shall hold office for one year, or until their
6 successors are selected.

7
8 The Commission shall adopt rules and regulations to govern proce-
9 dures and shall, by vote, set a time for regular meetings [which
10 shall be held at least once a month,] and shall determine the
11 manner in which special meetings may be called, held, and the
12 notice given. A majority of the regular members shall constitute
13 a quorum for all purposes. Members of the Parks and Recreation
14 Advisory Commission [must attend seventy five percent (75%) of
15 all regular meetings, of which they have notice, excluding excused
16 absences. Failure to attend seventy five percent (75%) of such
17 meetings shall constitute sufficient grounds for the Board of City
18 Commissioners, at its discretion, to remove said member and declare
19 the position vacant.] may be removed for malfeasance, misconduct
20 or neglect of duty pursuant to Title I, Chapter 19 of this Code.

21 Minutes of meetings of the Commission shall be filed with the
22 Clerk within ten (10) days following such meetings.

23 2-11-3: The duties of the Parks and Recreation Commission shall
24 be:

25 (A) [To act in a recommending capacity,] To make recommendations,
26 in cooperation with the Director of [Parks and the Director
27 of] Recreation[,] and Leisure Activities, to the Board of
28 City Commissioners on [all] matters pertaining to public parks
29 and public recreation and to cooperate with other governmental
30 agencies and civic groups [in the advance of] to facilitate
31 sound park and recreation planning.

32 [(B) To recommend to the Board of City Commissioners, in writing,

1 as to priorities for all expenditures for capital improve-
2 ments pertaining to areas of responsibility assigned to the
3 Parks and Recreation Advisory Commission.]

4 [(C)] (B) To aid in coordinating the parks and recreation
5 services with [the program for] other governmental
6 agencies and other voluntary organizations.

7 [(D)] (C) To assist in the functions of the [Parks and
8 Recreational] Department of Recreation and Leisure
9 Activities [with] which involve or affect the
10 public.

11 [2-11-4: The Director of Recreation or his representative shall
12 attend all meetings of the Commission and shall serve
13 as ex officio Secretary thereof. The Director of Parks or his
14 representative shall attend all meetings of the Commission.]

15 SECTION 2: If any section, subsection, subdivision,
16 paragraph, sentence, clause or phrase in this Chapter or any
17 part thereof, is for any reason held to be unconstitutional, or
18 invalid or ineffective by any court of competent jurisdiction,
19 such decision shall not affect the validity or effectiveness of
20 the remaining portions of this Chapter or any part thereof. The
21 Board of Commissioners of the City of Las Vegas hereby declares
22 that it would have passed each section, subsection, subdivision,
23 paragraph, sentence, clause or phrase thereof irrespective of
24 the fact that any one or more sections, subsections, subdivisions,
25 paragraphs, sentences, clauses or phrases be declared unconstitu-
26 tional, invalid or ineffective.

27 SECTION 3: All ordinances or parts of ordinances,
28 sections, subsections, phrases, sentences, clauses or paragraphs

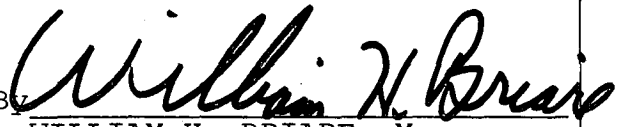

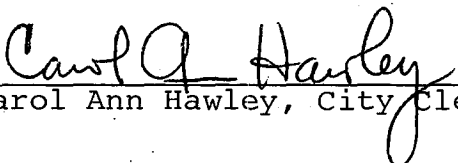
