4 AN ORDINANCE TO AMEND TITLE II, CHAPTER 4 OF THE MUNICIPAL CODE OF
5 THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION BY REPEALING THE
6 EXISTING CHAPTER 4 OF TITLE II, ADOPTING A NEW CHAPTER 4 WHICH
7 PROVIDES FOR THE UPDATING OF THE LAS VEGAS GOLF BOARD'S DUTIES
8 AND PROVIDES FOR THE DIRECTOR OF RECREATION AND LEISURE ACTIVITIES
9 OR HIS REPRESENTATIVE TO ATTEND GOLF BOARD MEETINGS; TO PROVIDE
10 FOR OTHER MATTERS PROPERLY RELATING THERETO; AND TO REPEAL ALL
11 ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Updates the duties and
responsibilities of the Las Vegas
Golf Board.

14 THE BOARD OF COMMISSIONERS OF THE CITY OF LAS VEGAS,
15 NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

16 SECTION 1: Title II of the Municipal Code of the City
17 of Las Vegas, Nevada, 1960 Edition, is hereby amended by repealing
18 Chapter 4 of Title II in its entirety.

19 SECTION 2: Title II of the Municipal Code of the City
20 of Las Vegas, Nevada, 1960 Edition, is hereby amended by enacting
21 a new Chapter 4 to read as follows:

22 2-4-1: A Board is hereby created to be known as the Las Vegas
23 Golf Board.

24 2-4-2: The Las Vegas Golf Board shall consist of five (5)
25 members, all of whom shall be residents and taxpayers
26 of the City. All members shall serve without compensation.

27 2-4-3: The Director of Recreation and Leisure Activities or his
28 representative shall attend all meetings of the Golf
29 Board and serve as the non-voting Secretary.

30 2-4-4: All members of the Las Vegas Golf Board shall be
31 appointed by the Board of City Commissioners.

32 As the current term of a Las Vegas Golf Board member expires, the
member or his successor shall be appointed for a term of five (5)
years. If a vacancy shall occur otherwise than by expiration of

1 a term of an appointed member, it shall be filled by appointment
2 for the unexpired portion of the term. Each year the Board of
3 Commissioners of the City shall appoint a replacement to the Las
4 Vegas Golf Board to fill the office of any member whose term
5 expires that year.

6 2-4-5: The Las Vegas Golf Board shall meet and organize by
7 electing from its membership a Chairman and such other
8 officers as in the judgment of such Board may be necessary.

9 2-4-6: The duties of the Las Vegas Golf Board shall be as
10 follows: To make recommendations, through the Director
11 of Recreation and Leisure Activities, to the Board of City Commis-
12 sioners on matters pertaining to the Municipal Golf Course,
13 including but not limited to, capital improvements and green fees
14 or any other charges to the public for use of the facilities.

15 SECTION 3: If any section, subsection, subdivision,
16 paragraph, sentence, clause or phrase in this Chapter or any
17 part thereof, is for any reason held to be unconstitutional, or
18 invalid or ineffective by any court of competent jurisdiction,
19 such decision shall not affect the validity or effectiveness of
20 the remaining portions of this Chapter or any part thereof. The
21 Board of Commissioners of the City of Las Vegas hereby declares
22 that it would have passed each section, subsection, subdivision,
23 paragraph, sentence, clause or phrase thereof irrespective of
24 the fact that any one or more sections, subsections, subdivisions,
25 paragraphs, sentences, clauses or phrases be declared unconstitu-
26 tional, invalid or ineffective.

27 SECTION 4: All ordinances or parts of ordinances,
28 sections, subsections, phrases, sentences, clauses or paragraphs

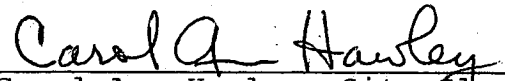
