ORDINANCE NO. 2194

AN ORDINANCE TO AMEND MAJOR STREET PLAN MAP ADOPTED BY ORDINANCE 1537 ON OCTOBER 6, 1971, INsofar AS IT RELATES TO MAIN STREET, BETWEEN STEWART AND BRIDGER AVENUES; TO PROVIDE FOR OTHER MATTERS PROPERLY RELATING THERETO; AND TO REPEAL ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: To amend Major Street Plan Map adopted by Ordinance 1537 insofar as it relates to a portion of Main Street, between Stewart and Bridger Avenues

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: The Major Street Plan of the City of Las Vegas, adopted by Ordinance No. 1537 on October 6, 1971, is hereby amended as follows:

A portion of Main Street from 90' in width to 88' in width generally located between Stewart and Bridger Avenues and more particularly to reduce the west half of Main Street from 50' to 48' from a point approximately 180' south of the south right-of-way line of Stewart Avenue to a point approximately 160' north of the north right-of-way line of Bridger Avenue.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Chapter or any part thereof, is for any reason held to be unconstitutional, or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Chapter or any part thereof. The Board of Commissioners of the City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions,

1 paragraphs, sentences, clauses or phrases be declared unconstitu-
2 tional, invalid or ineffective.

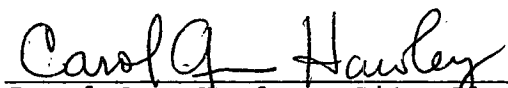
3 SECTION 3: All ordinances or parts of ordinances,
