Ordinance No. 2201

AN ORDINANCE TO AMEND TITLE I OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960 EDITION, BY REPEALING CHAPTER 18 OF SAID TITLE AND ADDING IN LIEU THEREOF A NEW CHAPTER, DESIGNATED CHAPTER 18, ADOPTING BY REFERENCE THE "INTERIM CIVIL SERVICE RULES" OF SAID CITY; TO PROVIDE FOR OTHER MATTERS PROPERLY RELATING THERETO; AND TO REPEAL ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Adopts Interim Civil Service Rules which incorporate the first three chapters of the Revised Civil Service Rules in place of the first three chapters of the existing Civil Service Rules.

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title I, Chapter 18, which incorporates the "Civil Service Rules and Regulations" by reference is hereby repealed in its entirety.

SECTION 2: Title I, Chapter 18, 1 is hereby amended by adding thereto a new chapter, to be designated as Chapter 18, reading as follows:

1-18-1: That a certain document, three copies of which is on file in the Office of the Clerk and designated as Interim Civil Service Rules, is hereby adopted by reference and made part of this Chapter as if the same was fully set forth herein.

SECTION 3: In the event of a conflict between the provisions of Part I of the Interim Civil Service Rules and the provisions of Part II of said Rules, the provisions of Part I shall control.

SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Chapter or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the

1 remaining portions of this Chapter or any part thereof. The
2 Board of Commissioners of the City of Las Vegas hereby declares
3 that it would have passed each section, subsection, subdivision,
4 paragraph, sentence, clause or phrase thereof irrespective of the
5 fact that any one or more sections, subsections, subdivisions,
6 paragraphs, sentences, clauses or phrases be declared unconstitu-
7 tional, invalid or ineffective.


8 SECTION 5: All ordinances or parts of ordinances,
9 sections, subsections, phrases, sentences, clauses or paragraphs
10 contained in the Municipal Code of the City of Las Vegas, Nevada,
11 1960 Edition, in conflict herewith are hereby repealed.


