Summary: Makes technical amendments in the general penalty clause of the City Code.

THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title I, Chapter 1, Section 7, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

1-1-7: GENERAL PENALTY:

Whenever in this Code or in any ordinance of the City, the doing of any act is [prohibited or is] made or declared to be unlawful or an offense or a misdemeanor, or whenever in such Code or ordinance the [doing of any act is required or the] failure to do any act is made or declared to be unlawful [, when] or an offense or a misdemeanor, if no specific penalty is provided therefor, the violation of any such provision of this Code or any ordinance shall be punished by a fine not exceeding one thousand dollars (\$1,000.00) or imprisonment for a term not exceeding six (6) months, or [both] any combination of such fine and imprisonment. 
violation of any provision of this Code or of any ordinance shall continue shall constitute a separate offense.

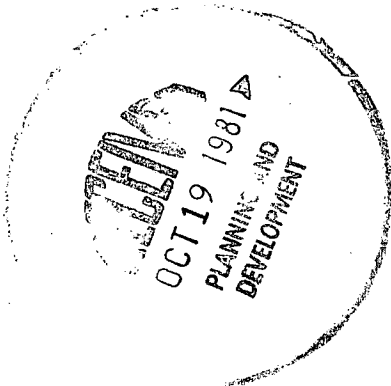
