1 Quarter (SE 1/4), North 89°20'27" East a
2 distance of 452.51 feet; thence parallel
3 with the East line of the Southeast Quarter
4 (SE 1/4) of the Southeast Quarter (SE 1/4)
5 of said Section 20, South 00°33'55" East
6 a distance of 144.31 feet; thence North
7 89°14'40" East a distance of 34.36 feet;
8 thence parallel with the East line of the
9 Southeast Quarter (SE 1/4) of the Southeast
10 Quarter (SE 1/4) of said Section 20, South
11 00°33'55" East a distance of 185.14 feet to
12 the TRUE POINT OF BEGINNING.

13 SECTION 2: That said Board of Commissioners has deter-
14 mined and does hereby determine, that said described territory
15 meets the requirements provided by law for annexation to the City
16 of Las Vegas for the following reasons:

17 A. The area to be annexed was contiguous to the
18 City's boundaries at the time the annexation pro-
19 ceedings were instituted;

20 B. More than one-eighth (1/8) of the aggregate
21 external boundaries of the area are contiguous to the
22 City of Las Vegas;

23 C. The territory proposed to be annexed is not
24 included within the boundaries of another incor-
25 porated city;

26 D. The City of Las Vegas is eligible to annex the
27 area described in this report since the landowners
28 have signed a petition requesting annexation to
29 the City, said petition constituting one hundred
30 percent (100%) of the owners of record of individual
31 lots or parcels of land within the annexation area,
32 and have submitted a letter of intent to develop
the land.

SECTION 3: The City of Las Vegas will provide police
protection through the Las Vegas Metropolitan Police Department,
fire protection, street maintenance, and library services
immediately upon annexation. Garbage collection by the company

1 franchised by the City will also be provided immediately. The
2 City sanitary sewer system will serve the proposed annexation
3 area. Any connection to or extension of this sewer line to serve
4 the annexation area shall be at the expense of the landowners.
5 Other services, such as participation in the City's recreational
6 programs, special educational classes and programs, public works
7 planning, building inspections, and other City Hall services
8 will also be available immediately. Utilities such as gas,
9 electricity, telephone, and water are provided by private utility
10 companies and other services to the area will not be affected by
11 annexation. Street paving, curbs and gutters, sidewalks and
12 street lights which are not in place at the time of annexation
13 will be installed in the presently developed areas upon the
14 request of the property owners and at their expense by means
15 of special assessment districts. Such improvements will be
16 extended into the undeveloped areas as development takes place
17 and the need therefor arises, and will be located according to
18 the needs of the area at that time. Such installations will
19 also be made at the expense of the property owners, either by
20 means of special assessment districts or as prerequisites to the
21 approval of subdivision plats or the issuance of building permits,
22 re-zonings, zone variances or special use permits.

23 SECTION 4: The annexation of said described territory
24 shall become effective on the 13th day of November, 1981, and on
25 such date the City of Las Vegas will have the funds appropriated
26 in sufficient amount to finance the extension into said described
27 territory of police protection, fire protection, street maintenance,
28 street sweeping, and street lighting maintenance.

29 SECTION 5: Said described territory, together with the
30 inhabitants and property thereof, shall, from and after the 13th
31 day of November, 1981, be subject to all debts, laws, ordinances
32 and regulations in force in the City of Las Vegas and shall be

1 entitled to the same privileges and benefits as other parts of
2 said City, and shall be subject to municipal taxes levied by the
3 City of Las Vegas, Nevada.

4 SECTION 6: The City Engineer of the City of Las Vegas,
5 Nevada, is hereby instructed to cause to be prepared an accurate
6 map or plat of said described territory and to record the same,
7 together with a certified copy of this ordinance in the office of
8 the County Recorder of Clark County, Nevada, which said recording
9 shall be done prior to the 13th day of November, 1981.

10 SECTION 7: If any section, subsection, subdivision,
11 paragraph, sentence, clause or phrase in this Chapter or any
12 part thereof, is for any reason held to be unconstitutional, or
13 invalid or ineffective by any court of competent jurisdiction,
14 such decision shall not affect the validity or effectiveness of
15 the remaining portions of this Chapter or any part thereof. The
16 Board of Commissioners of the City of Las Vegas hereby declares
17 that it would have passed each section, subsection, subdivision,
18 paragraph, sentence, clause or phrase thereof irrespective of
19 the fact that any one or more sections, subsections, subdivisions,
20 paragraphs, sentences, clauses or phrases be declared unconstitu-
21 tional, invalid or ineffective.

22 SECTION 8: All ordinances or parts of ordinances,
23 sections, subsections, phrases, sentences, clauses or paragraphs

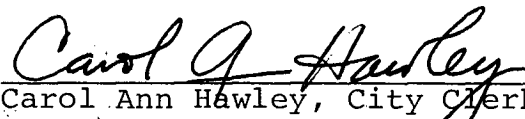

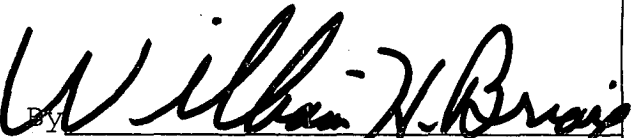
