THE BOARD OF CITY COMMISSIONERS OF THE CITY OF LAS VEGAS, NEVADA, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title IX, Chapter 8, Section 24, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

9-8-24: [No] Whenever a lot which has been purchased from the City in accordance with the provisions [hereof shall be] of this Chapter is [reconveyed] conveyed to a third party, [without the prior approval of] notice of such conveyance shall be given to the Superintendent of Cemeteries. [and in such] In those instances where any such lot is [reconveyed] conveyed either to the City or to a third party [as herein provided], the City shall charge a reasonable fee on account thereof as shall from time to time be decided by the Board of Commissioners.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Chapter or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such

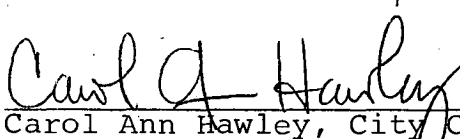
1 decision shall not affect the validity or effectiveness of the

4 that it would have passed each section, subsection, subdivision,
5 paragraph, sentence, clause or phrase thereof irrespective of the
6 fact that any one or more sections, subsections, subdivisions,
7 paragraphs, sentences, clauses or phrases be declared unconstitu-
8 tional, invalid or ineffective.
