SECTION 1: Title I, Chapter 21, Section 1, of the Municipal Code of the City of Las Vegas, Nevada, 1960 Edition, is hereby amended to read as follows:

1-21-1: ISSUANCE OF COMPLAINT

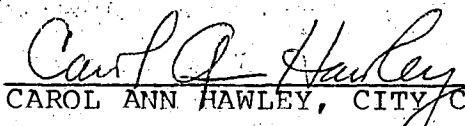
Any citizen who believes himself to have been the victim of any violation of his rights or of any violation of duty by any member of any department of the City may make a complaint, in writing and under oath, to the City Attorney within one month[.] of the date of the alleged violation.

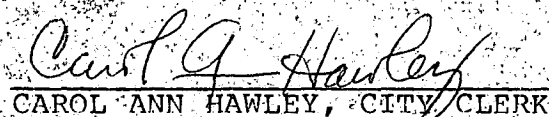
