Summary: Authorizes the City Council, in
accordance with State law, to adopt certain
minor amendments to the General Plan without
8 Planning Commission action and without
9 limitation as to frequency.

9 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
10 AS FOLLOWS:

11 SECTION 1: Title 19, Chapter 18, Section 30, of the Municipal Code of the City of
12 Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new subsection, designated
13 as Subsection (J), reading as follows:

14 (J) Certain Minor Amendments. Notwithstanding any other provision of this Section, the City
15 Council, upon appropriate notice and public hearing, may amend the General Plan, or any part thereof,
16 without action by the Planning Commission and without limitation as to frequency, in order to:

17 (1) Change a boundary that is based on a geographical feature, including, without
18 limitation, topography, slopes, hydrographic features, wetland delineation and floodplains, when
19 evidence is produced that the mapped location of the geographical feature is in error;

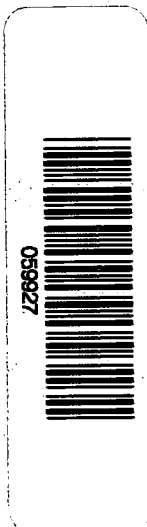
20 (2) Reflect the alteration of the name of a jurisdiction, agency, department or district by
21 the governing body, governing board or other governing authority of the jurisdiction, agency,
22 department or district, as applicable, or by another entity authorized by law to make such an alteration;

23 or

24 (3) Update statistical information that is based on a new or revised study.

25 SECTION 2: For purposes of Section 2.100(3) of the City Charter, LVMC 19.18.030
26 is deemed to be a subchapter rather than a section.


27 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or
28 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or





1 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
2 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
3 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
4 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
5 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
6 invalid or ineffective.

7 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,
8 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
9 1983 Edition, in conflict herewith are hereby repealed.

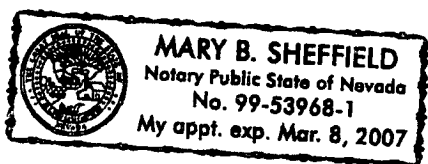
