AN ORDINANCE TO AMEND ORDINANCE NO. 5774 (REGARDING THE EXTENSION OF THE CORPORATE LIMITS OF THE CITY) TO CORRECT THE LEGAL DESCRIPTION OF THE ANNEXED TERRITORY, AND TO PROVIDE FOR OTHER RELATED MATTERS. (PERTAINING TO ANNEXATION ANX-5528)

Summary: Amends Ordinance No. 5774, relating to the annexation of property, to correct the legal description contained therein (General Location - the area bounded by Iron Mountain Road to the south, Puli Road to the west, Hualapai Way to the east, and Moccasin Road to the north).

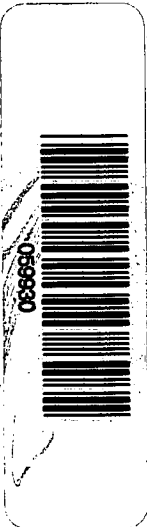
THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN

AS FOLLOWS:

SECTION 1: Ordinance No. 5774 of the City of Las Vegas is hereby amended as set forth in Section 2 of this Ordinance.

SECTION 2: The description of the territory to be annexed by Ordinance No. 5774, as set forth in Exhibit "A" attached to that ordinance, is incomplete and inaccurate in a few minor respects. The complete and correct description is set forth as Exhibit "A" to this Ordinance, and shall supersede and replace the legal description attached to Ordinance No. 5774.

SECTION 3: The amendment represented in Section 1 of this Ordinance is intended to correct errors. Therefore, it is the intent of the City Council that, to the extent legally permissible, the amendments be effective as of the 10th day of June, 2005—the effective date of Ordinance No.



1 5774, and it is so declared. If it is subsequently determined that it is not legally permissible to make
2 the amendments effective as of the 10th day of June, 2005, they shall be effective as of the date this
3 Ordinance is recorded.

4 SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or
5 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
6 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
7 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
8 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
9 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
10 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
11 invalid or ineffective.

12 SECTION 5: All ordinances or parts of ordinances or sections, subsections, phrases,
13 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
14 1983 Edition, in conflict herewith are hereby repealed.

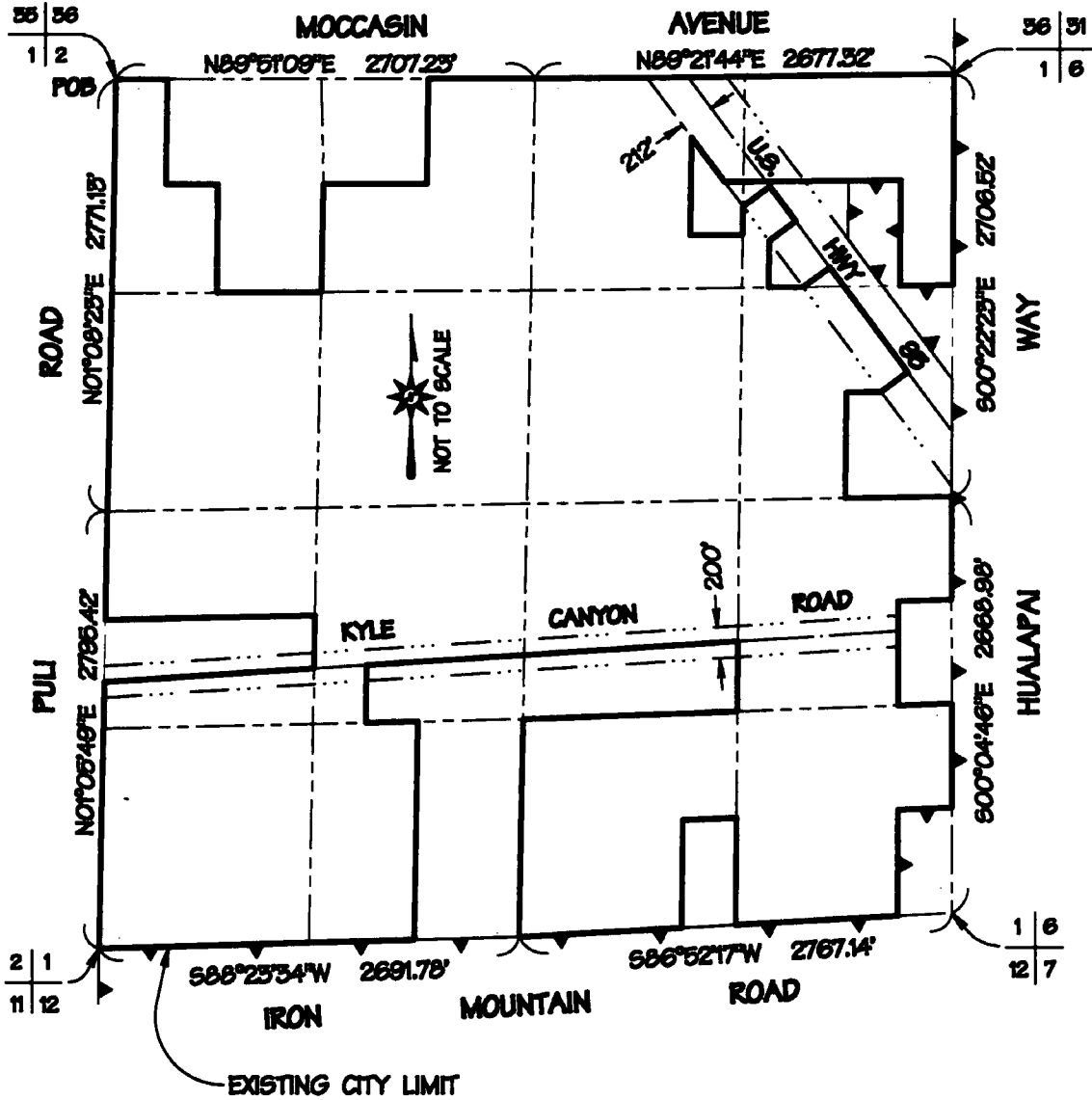
