4 **SECONDHAND DEALER LICENSING REQUIREMENTS, AND TO PROVIDE FOR OTHER**
5 **RELATED MATTERS.**

7 Summary: Exempts retail business licensees
8 from secondhand dealer licensing requirements
9 when they are buying, selling or trading used
10 compact discs, digital video discs, video games,
11 videotapes, cassettes or sound recordings which
12 were purchased (or received as trade-ins) from
13 their retail customers, provided that such
14 transactions resulted in the retail customers only
15 receiving credit toward their purchase or rent of
16 new or used items of the same kind from the
17 licensees.

18 **THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN**
19 **AS FOLLOWS:**

20 **SECTION 1: Title 6, Chapter 74, Section 40, of the Municipal Code of the City of**
21 **Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:**

22 **6.74.040: This Chapter does not apply to:**

23 (A) Dealers of used vehicles as to those activities permitted by a license issued by
24 the State Department of Motor Vehicles pursuant to NRS 482.322 but not as to those activities
25 referred to in Section 6.74.060;

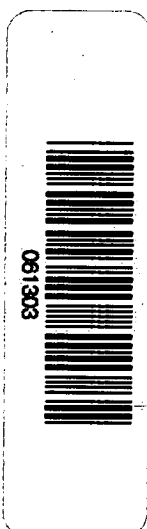
26 (B) The buying, selling or trading by a licensed business of used articles which were
27 acquired as a trade-in or a credit upon the purchase of a new article of the same kind on a one-for-one
28 basis;

(C) The taking in pawn or the selling of unredeemed personal property by a licensed
pawnbroker pursuant to Chapter 6.60;

(D) The buying, selling or trading of used books, newspapers and periodicals;

(E) The buying, selling or trading of coins which are not a part of any jewelry;

(F) The buying, selling or trading by a licensed retail business of used video games,
videotapes, cassettes, digital video discs, compact discs or sound recordings which have been
purchased (or received as trade-ins) from its retail customers, provided that credit only has been given



1 as consideration for the purchases or trade-ins, which credit then can only be used by its retail
2 customers for the rental or purchase of new or used items referenced in this Subsection at any of its
3 licensed business premises.

4 [(F)] (G) A convention or trade show not exceeding fourteen days in length, provided that
5 convention or trade show exhibitors do not purchase secondhand or used personal property at the
6 convention or trade show; or

7 [(G)] (H) A person selling used or personal property under the umbrella of another
8 licensee's gift and novelty or Class IV secondhand dealer license, provided the sales are made at the
9 main business premises of the gift and novelty or Class IV secondhand dealer licensee and the person
10 does not purchase used or personal property at the main business premises of the licensee.

11 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or
12 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
13 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
14 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
15 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
16 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
17 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
18 invalid or ineffective.







**BUSINESS IMPACT STATEMENT
BILL NO. 2006-14**

This business impact statement was prepared pursuant to NRS 237.090 to address the impact of a proposed ordinance, Bill No. 2006-14 that will permit licensed retail merchants, without first being licensed as secondhand dealers, to buy, sell or take as trade-in used compact discs, digital video discs, video games, videotapes, cassettes or sound recordings from their retail customers provided that such transactions resulted in the retail customers only receiving credit toward their purchase or rent of new or used items of the same kind from the licensed retail merchants.

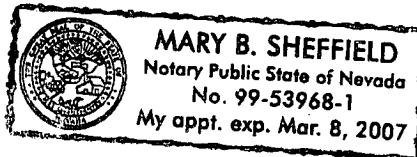

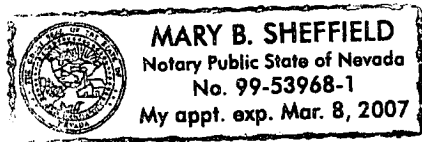
