AN ORDINANCE RELATING TO THE DEPARTMENTS OF THE CITY; AMENDING VARIOUS PROVISIONS OF TITLE 2, CHAPTER 9, OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION, TO CHANGE THE NAME OF THE DEPARTMENT OF PARKS AND LEISURE ACTIVITIES TO THE DEPARTMENT OF LEISURE SERVICES; TO CREATE WITHIN THE DEPARTMENT OF PUBLIC WORKS THE STREETS, SANITATION, PARKS/OPEN SPACES DIVISION TO BE RESPONSIBLE FOR THE FUNCTIONS INDICATED; AND TO UPDATE THE LIST OF DIVISIONS WITHIN THOSE TWO DEPARTMENTS; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HERewith.

Summary: Formalizes the transfer of responsibility for parks maintenance and construction to the Department of Public Works.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 2, Chapter 9, Section 10, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.09.010: The departments of the City shall consist of the following:

- (A) Building and Safety;
- (B) City Attorney;
- (C) Detention and Enforcement;
- (D) Finance and Business Services;
- (E) Fire Services;
- (F) General Services;
- (G) Human Resources;
- (H) Information Technologies;
- (I) Municipal Court;
- (J) Neighborhood Services;
- (K) [Parks and Leisure Activities;] Leisure Services;
- (L) Planning and Development;
- (M) Public Works.

1 SECTION 2: Title 2, Chapter 9, Section 130, of the Municipal Code of the City of Las
2 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

3 **2.09.130:** The Department of [Parks and Leisure Activities] Leisure Services shall consist of the
4 following divisions:

- 5 (A) [Programs and facilities;] Adaptive recreation;
- 6 (B) [Cultural affairs;] Administration;
- 7 (C) [Parks and open spaces;] Cultural & community affairs;
- 8 (D) [Aquatics;] Recreation;
- 9 (E) Senior citizens [center.] program.

10 SECTION 3: Title 2, Chapter 9, Section 150, of the Municipal Code of the City of
11 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

12 **2.09.150:** The Department of Public Works shall consist of the following divisions:

- 13 (A) [Electrical;] Administration;
- 14 (B) [Streets;] City engineer;
- 15 (C) [Demand services;] Engineering planning;
- 16 (D) [Sanitation;] Environmental (Water pollution control facility);
- 17 (E) [City engineering;] Streets, sanitation, parks/open spaces;
- 18 (F) [Public services;] Traffic engineering & field operations.
- 19 [(G) Land development services.]

20 SECTION 4: The changes reflected by this Ordinance shall be effective as of June 29,
21 1998.

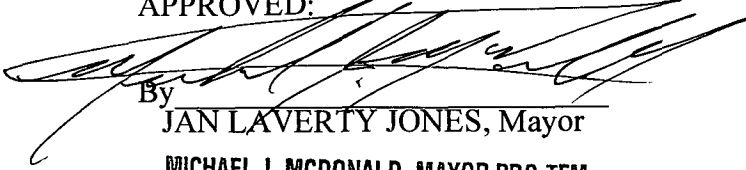
22 SECTION 5: If any section, subsection, subdivision, paragraph, sentence, clause or
23 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid
24 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
25 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
26 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
27 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
28 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,

1 invalid or ineffective.

2 SECTION 6: All ordinances or parts of ordinances or sections, subsections, phrases,
3 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
4 1983 Edition, in conflict herewith are hereby repealed.
