7 CATS IN PLACE OF EXISTING PROVISIONS REQUIRING ONE LICENSE AND FEE FOR  
8 THE LIFE OF THE ANIMAL; PROVIDING FOR OTHER MATTERS PROPERLY RELATING  
9 THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN

15 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN  
16 AS FOLLOWS:

17 SECTION 1: Title 7, Chapter 8, Section 20, of the Municipal Code of the City of Las  
18 Vegas, Nevada, 1983 Edition, is hereby repealed.

19 SECTION 2: Title 7, Chapter 8, Section 60, of the Municipal Code of the City of Las  
20 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

21 **7.08.060:** The following [lifetime] annual fees shall be paid for each license at the time of  
22 issuance of said license for each dog or cat:

<u>Classification</u>	<u>Fee</u>
(A) Dog, male	\$ <del>[50.00]</del> <u>25.00</u>
(B) Dog, male, neutered	10.00
(C) Cat, male	<del>[50.00]</del> <u>25.00</u>
(D) Cat, male, neutered	10.00
(E) Dog, female	<del>[50.00]</del> <u>25.00</u>
(F) Dog, female, spayed	10.00
(G) Cat, female	<del>[50.00]</del> <u>25.00</u>
(H) Cat, female, spayed	10.00

23 SECTION 3: Title 7, Chapter 8, Section 100, of the Municipal Code of the City of Las  
24 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

25 **7.08.100:** Each dog or cat license issued by the City shall be effective for [the lifetime of the  
26 animal] one year following its issuance or until there is a change in ownership thereof in which case  
27 the new owner has thirty days from the date of the transfer of possession to obtain a new annual


1 license, [All applicable fees will be required] subject to payment of all applicable fees.

2 SECTION 4: If any section, subsection, subdivision, paragraph, sentence, clause or  
3 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional, or invalid  
4 or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or  
5 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the  
6 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,  
7 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,  
8 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,  
9 invalid or ineffective.

10 SECTION 5: All ordinances or parts of ordinances or sections, subsections, phrases,  
11 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,  
12 1983 Edition, in conflict herewith are hereby repealed.




