AN ORDINANCE TO AMEND TITLE XI, CHAPTER 1, SECTION 3, MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1960, BY AMENDING THE LAND USE PLAN MAP ADOPTED BY THE CITY OF LAS VEGAS, AND CHANGING THE ZONING DESIGNATION OF CERTAIN AREAS OF THE SAID MAP.

The Board of Commissioners of the City of Las Vegas do ordain as follows:

SECTION 1. The Land Use Plan Map adopted by Title XI, Chapter 1, Section 3, Municipal Code of the City of Las Vegas, Nevada, 1960, is hereby amended to read as follows:

From R-E to R-1: (Z-17-61)

Parcel #1

The East half of the Southeast quarter of Section 26, Township 20 South, Range 60 East, except the West 750'.

Parcel #2

The West half of the Southeast quarter of Section 26, Township 20 South, Range 60 East, except for the following described parcel:

Beginning at the Northeast corner of the Northwest quarter of the southeast quarter of said Section 26, thence west along the centerline of said Section 26 a distance of 500 feet; thence Southeasterly to the southeast corner of the said Northwest quarter of the Southeast quarter of Section 26, thence north along the East line of said quarter section to the point of beginning.

SECTION 2. All ordinances, parts of ordinances, chapters, sections, subsections, paragraphs, sentences, clauses or phrases contained in the Municipal Code of the City of Las Vegas, Nevada, 1960, in conflict herewith are hereby repealed.


