AN ORDINANCE RELATING TO EMERGENCY MANAGEMENT; AMENDING TITLE 2, CHAPTER 30 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION; PROVIDING PROCEDURES FOR PROCLAMATION OF A DISASTER EMERGENCY; GRANTING PROCLAMATION POWERS TO THE MAYOR; PROVIDING PROCLAMATION AUTHORITY FOR SUCCESSORS IN THE ABSENCE OF THE MAYOR; SPECIFYING THE RESTRICTIONS WHICH MAY BE IMPOSED DURING A DISASTER EMERGENCY; PROVIDING FOR NOTIFICATION OF A PROCLAMATION OF DISASTER EMERGENCY; ESTABLISHING THE CITY MANAGER AS THE HEAD OF THE OFFICE OF EMERGENCY MANAGEMENT; PROVIDING THAT A MEMBER OF THE CITY COUNCIL SHALL BE A MEMBER OF THE MANAGEMENT COMMITTEE FOR EMERGENCY OPERATIONS; PROVIDING THAT THE MAYOR BE INCLUDED IN ALL RECOMMENDATIONS AND POLICY GUIDANCE FROM THE COMMITTEE; PROVIDING FOR MISDEMEANOR PUNISHMENT FOR ALL PERSONS VIOLATING ANY PROVISION OF THIS ORDINANCE OR ANY RESTRICTION IMPOSED BY PROCLAMATION AUTHORIZED BY THIS ORDINANCE; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Provides procedures for proclamation of a disaster emergency, lists those who may proclaim a disaster emergency, lists the restrictions that may be proclaimed, and provides penalty for violation.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS, DOES HEREBY ORDAIN
AS FOLLOWS:

SECTION 1: Title 2, Chapter 30, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.30.010 Purpose. The purpose of this Chapter is to:

- (A) Provide for the safety and welfare of the people and the protection of their property within the City in a disaster situation through organized emergency operations; and
- (B) Provide for the coordination of such operation with appropriate public authorities, private persons, business associations and organizations and

1 City agencies having the resources for providing disaster assistance.

2 **2.30.020 Definitions.** As used in this Chapter, unless the context otherwise requires, the
3 following words shall have the meaning ascribed:

4 (A) "Disaster" means a flood, fire of extraordinary proportion, earthquake,
5 storm, epidemic, actual or threatened riot, serious domestic violence,
6 insurrection, general war or other major calamity.

7 (B) "Emergency operations" means planning, preparation for, and carrying out
8 of all emergency functions necessary to prevent, minimize and recover from
9 the effects of a disaster.

10 **2.30.030 [Existence of disaster emergency -- Proclamation Authority.**

11 The City Council, or if a quorum of the Council is not present, the City
12 Manager, until such time as the City Council can be called into session,
13 shall proclaim the existence of a disaster emergency whenever in its
14 judgment one is deemed to have occurred or is imminent.]

15 ***Proclamation of Disaster Emergency.***

16 (A) *A state of disaster emergency shall be deemed to exist whenever during any*
17 *disaster, public safety authorities are unable to maintain public order or*
18 *afford adequate protection for lives or property.*

19 (B) *The Mayor, pursuant to the powers granted in Title III, Section 3.010 of the*
20 *Charter for the City of Las Vegas, shall have the authority to declare a*
21 *State of Disaster Emergency by proclamation. Upon the absence or the*
22 *unavailability of the Mayor, the Mayor Pro Tem shall have the powers and*
23 *authority granted to the Mayor in this Chapter, and upon the absence or*
24 *unavailability of the Mayor, and the Mayor Pro Tem, the powers shall be*
25 *delegated to any two of the remaining members of the City Council. Upon*
26

1 *the absence or unavailability of two Council members, the powers shall be*
2 *delegated to the City Manager or, upon the absence or unavailability of the*
3 *City Manager, the Director of Fire Services.*

4 (C) *The Mayor is hereby authorized and empowered to limit by the*
5 *proclamation the application of all or any part of the restrictions described*
6 *in this Section to any area specifically designated or described within the*
7 *corporate limits of the City and to specific hours of the day or night.*

8 (D) *The Mayor shall proclaim the end of such state of disaster emergency or all*
9 *or any part of the restrictions imposed as soon as circumstances warrant or*
10 *when directed to do so by the City Council.*

11 (E) *During the existence of a proclaimed state of disaster emergency, the Mayor*
12 *may impose by proclamation any or all of the following restrictions:*

13 (1) *Prohibit or regulate the possession off one's own*
14 *premises of explosives, firearms, ammunition, or*
15 *dangerous weapons of any kind, and prohibit the*
16 *purchase, sale, transfer or other disposition thereof;*

17 (2) *Prohibit or regulate the buying or selling of*
18 *intoxicating beverages of any kind, and their*
19 *consumption off one's own premises;*

20 (3) *Prohibit or regulate the sale of gasoline (except when*
21 *directly introduced into a motor vehicle), kerosene,*
22 *naphtha, or any other explosive or inflammable fluids*
23 *or substances;*

24 (4) *Prohibit or regulate pedestrian or motor vehicle*
25 *travel or presence upon any public street, highway,*
26

1 alley, or roadway or upon any other public property,
2 including the proclamation of a curfew;

3 (F) Any proclamation may be extended, altered, or repealed in any particular
4 during the continued or threatened existence of a state of emergency by the
5 issuance of a subsequent proclamation.

6 (G) Upon the declaration of a state of disaster emergency, the City Manager
7 shall post a written notice of such declaration upon the special outside City
8 Hall bulletin board, and shall notify by telephone not less than two
9 newspapers of general circulation within the City, at least three television
10 stations and at least three radio stations broadcasting in Clark County.
11 When practicable, the City Manager shall also cause the written notice to
12 be published, in its entirety, at least four days each week in a newspaper
13 of general circulation in the City until the state of emergency is declared to
14 be terminated.

15 (H) Any proclamation made pursuant to this Section shall be presented to the
16 City Council as soon as possible, but in any case, within 48 hours. The
17 Council's consideration of such proclamation shall be deemed to be an
18 emergency for purposes of the Nevada Open Meeting Law. Notwithstanding
19 any provision of this Section, no proclamation made hereunder shall be
20 deemed invalid or be deemed to expire by the City Council's failure to
21 convene or to take action concerning the proclamation. In considering any
22 proclamation pursuant to this Subsection (H), the Council may take such
23 action as is described in Subsection (D) of this Section.

24 **2.30.040 Office of Emergency Management Operations -- Created [Appointment**
25 **of Office Head].**
26

- 1 (A) A board is created to be known as the Office of Emergency Operations.
- 2 (B) The City Manager shall [appoint a] *be the* head of the Office of Emergency
- 3 Operations to be known as the Coordinator of Emergency Operations *and*
- 4 *must act as the Coordinator of Emergency Operations during a disaster*
- 5 *emergency. At all other times, the City Manager may appoint a substitute*
- 6 *to act in the City Manager's stead, to be known as the Acting Coordinator*
- 7 *of Emergency Operations. Upon the absence or the unavailability of the*
- 8 *City Manager, the Senior Deputy City Manager shall be the Coordinator of*
- 9 *Emergency Operations.*

10 **2.30.050 Coordinator -- Authority.**

11 The Coordinator of Emergency Operations is authorized and directed to:

- 12 (A) Prepare and maintain an emergency operations plan and an emergency
- 13 resources management plan for the City, in support of and in accordance
- 14 with Federal, State and County emergency plans and guidance;
- 15 (B) Designate and prepare standard operating procedures for an Emergency
- 16 Operation Center from which centralized direction and control of the
- 17 emergency operations may be exercised;
- 18 (C) Establish an Emergency Operations Organization, utilizing City, public and
- 19 private resources for this purpose;
- 20 (D) Monitor and supervise the Emergency Operations Organization at drills, and
- 21 train and prepare the organization to effect the purpose of this Chapter;
- 22 (E) Represent the Emergency Operations Organization of the City in all
- 23 dealings with public or private agencies pertaining to emergency operations,
- 24 except that the Sheriff of the Las Vegas Metropolitan Police Department
- 25 will provide such representation in all matters dealing with riot, serious
- 26

1 domestic violence, insurrection, or other civil disobedience as provided by
2 provision of the Nevada Revised Statutes;

3 (F) Recommend to the [City Manager, for presentation to the] City Council,
4 mutual aid agreements with adjoining jurisdictions determined essential to
5 any part of emergency operations;

6 (G) Execute the emergency operations plan and coordinate the emergency
7 operations organizations upon the proclamation of a disaster emergency by
8 the *Mayor, or successor as contained in Section 2.30.030(B)*. [City Council
9 or, in the absence of the City Council, the City Manager. The Coordinator
10 of Emergency Operations shall be under the supervision of the City
11 Manager.]

12 **2.30.060 Management Committee Created -- Membership.**

13 (A) A Management Committee for Emergency Operations (hereinafter
14 "Committee") is created. The Committee shall be composed of *one*
15 *member of the City Council and* not less than five persons who are
16 appointed by the City Manager and selected from the Directors and Deputy
17 Directors of Departments of the City.

18 (B) The Director of Fire Services will be the Chairman of the Committee.

19 (C) The Committee shall, as a specific function, provide technical and policy
20 guidance to *the Mayor*, the City Council and the Coordinator of Emergency
21 Operations.

22 (D) The Committee shall approve such emergency operations plans as prepared
23 by the Coordinator of Emergency Operations and recommend to *the Mayor*,
24 the City Manager and City Council the adoption of the plans.

25 (E) The members of the Committee shall be the primary staff of the Emergency
26

1 Operations Organization and the Emergency Operations Center and shall
2 execute the emergency operations plan to accomplish the purpose of this
3 Chapter.

4 **2.30.070 NRS Sections 414.110 and 414.120 adopted.**

5 NRS Sections 414.110, Immunity and Exemption, and 414.120, Limitation of
6 Private Liability of NRS Chapter 414, Emergency Management, are adopted and
7 incorporated as [it pertains] *they pertain* to political subdivisions of the State.

8 **2.30.080 Use and Cooperation of City Services, Equipment, Supplies and Facilities.**

9 For the purposes of this Chapter, [the City Manager] *the Mayor*, the Management
10 [of] *Committee for* Emergency Operations, and the Coordinator of Emergency
11 Operations shall utilize the services, equipment, supplies and facilities of existing
12 departments, officers and agencies of the City to the maximum extent practicable,
13 and the officers and personnel of all such departments are directed to cooperate and
14 extend such services and facilities upon request.

15 **2.30.090 Prohibited Acts During Disaster Emergencies.**

16 It is unlawful for any person during a disaster emergency:

- 17 (A) To obstruct, hinder or delay any member of the Emergency Operations
18 [Organizations] *Organization* in the enforcement of any lawful rule or
19 regulation imposed upon him by virtue of this Chapter;
- 20 (B) [To do any act forbidden by any unlawful rule or regulation issued pursuant
21 to this Chapter, if such act is of such nature as to imperil the lives and
22 property of the inhabitants of the City or to permit, hinder or delay the
23 protection thereof;] *To violate any provision of any restriction imposed by*
24 *any proclamation authorized by this ordinance;*
- 25 (C) To wear, carry or display, without authority, any means of identification,
26

1 uniform or clothing of a member of the Emergency Operations Organization
2 or to use any such devices to gain entry into the scene of a disaster
3 emergency or an Emergency Operations Center.

4 **2.30.100 Penalty.**

5 *The violation of any provision of this ordinance, or of any restriction*
6 *imposed by proclamation authorized by this ordinance, shall constitute a*
7 *misdemeanor, punishable by a fine not to exceed one thousand dollars*
8 *(\$1000.00) and/or jail not exceeding six months.*

9 SECTION 2: All words appearing in bold face type are suggested titles for the respective
10 chapters and are not part of the language of this ordinance.

11 SECTION 3: If any section, subsection, subdivision paragraph, sentence, clause or
12 phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or
13 invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
14 validity or effectiveness of the remaining portions of this ordinance or any part thereof.

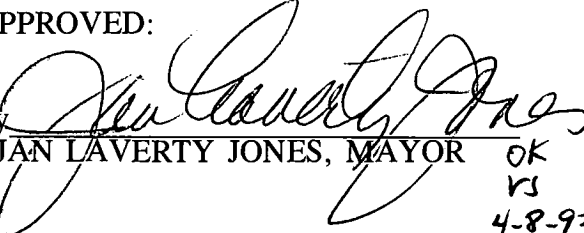

- (B) The City Manager shall [appoint a] *be the* head of the Office of Emergency Operations to be known as the Coordinator of Emergency Operations *and must act as the Coordinator of Emergency Operations during a disaster emergency. At all other times, the City Manager may appoint a substitute to act in in stead to be known as the Acting Coordinantor of Emergency Operations. Upon the absence or the unavailability of the City Manager, the Senior Deputy City Manager shall be the Coordinator of Emergency Operations.*

2.30.050 Coordinator -- Authority.

The Coordinator of Emergency Operations is authorized and directed to:

- (A) Prepare and maintain an emergency operations plan and an emergency resources management plan for the City, in support of and in accordance

1 with Federal, State and County emergency plans and guidance;

2 (B) Designate and prepare standard operating procedures for an Emergency
3 Operation Center from which centralized direction and control of the
4 emergency operations may be exercised;

5 (C) Establish an Emergency Operations Organization, utilizing City, public and
6 private resources for this purpose;

7 (D) Monitor and supervise the Emergency Operations Organization at drills, and
8 train and prepare the organization to effect the purpose of this Chapter;

9 (E) Represent the Emergency Operations Organization of the City in all
10 dealings with public or private agencies pertaining to emergency operations,

- (B) [To do any act forbidden by any unlawful rule or regulation issued pursuant to this Chapter, if such act is of such nature as to imperil the lives and property of the inhabitants of the City or to permit, hinder or delay the protection thereof;] *To violate any provision of any restriction imposed by any proclamation authorized by this ordinance;*
- (C) To wear, carry or display, without authority, any means of identification, uniform or clothing of a member of the Emergency Operations Organization or to use any such devices to gain entry into the scene of a disaster emergency or an Emergency Operations Center.

2.30.100 Penalty.

The violation of any provision of this ordinance, or of any restriction imposed by proclamation authorized by this ordinance, shall constitute a misdemeanor, punishable by a fine not to exceed one thousand dollars (\$1000.00) and/or jail not exceeding six months.

SECTION 2: All words appearing in bold face type are suggested titles for the respective chapters and are not part of the language of this ordinance.

SECTION 3: If any section, subsection, subdivision paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the

1 validity or effectiveness of the remaining portions of this ordinance or any part thereof.
