AN ORDINANCE RELATING TO LIQUOR CONTROL; AMENDING TITLE 6, CHAPTER 50 OF THE MUNICIPAL CODE OF THE CITY OF LAS VEGAS, NEVADA, 1983 EDITION; PROVIDING FOR THE DISPLAY OF ALCOHOLIC BEVERAGES IN QUANTITIES OF NOT LESS THAN 750 MILLILITERS AT LOCATIONS WHERE "OFF-SALE" IS PERMITTED; DESCRIBING THE AREAS WITHIN SAID LOCATIONS WHERE THE ALCOHOLIC BEVERAGES MAY BE DISPLAYED; LISTING THE TIMES OF THE YEAR WHEN SAID ALCOHOLIC BEVERAGES MAY BE DISPLAYED; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

Summary: Permits retail stores, other than taverns which are licensed for packaged liquor sales to display alcoholic beverages in quantities not less than 750 milliliters at ends of shopping aisles.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS, DOES HEREBY
ORDAIN AS FOLLOWS:

SECTION 1: Title 6, Chapter 50, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6.50.360 (A) Whenever an "off-sale" of alcoholic beverages is made, the alcoholic beverages, except beer, wine and coolers, must only be displayed for sale in an area of the licensed premises in which such alcoholic beverages are not accessible by persons under the age of twenty-one years. This area must be kept under the exclusive control of a person who is at least twenty-one years of age. When self-service of alcoholic beverages, except beer, wine and coolers, is provided, the area in which the alcoholic beverages are displayed must be partitioned from the rest of the premises; provided, however, that *alcoholic beverages in quantities of not less than seven hundred fifty milliliters may be displayed for certain special holidays or holiday season promotions, as specifically enumerated herein below, in grocery stores having at least 25,000 sq.ft. of area open to the public in unrestricted areas limited to the end sections of shopping aisles facing the front of the grocery store where such displays are visible to employees of the licensee*

1 who are at least twenty-one years of age. Said employees and management personnel of such
2 grocery stores shall have completed an alcoholic awareness training program approved by the
3 Director of the Department of Business Activity. [s]Such alcoholic beverages may be selected by
4 the customer and purchased at a common check-out stand at which nonalcoholic beverages may
5 be purchased. No self-service shall be permitted in original sealed or corked containers in
6 quantities less than one pint, measured in the English system of weights and measures, or in
7 quantities less than three hundred seventy-five milliliters, measured in the metric system of
8 weights and measures.

9 (B) *Special Holiday Promotions.* The display of alcoholic beverages for special
10 holidays listed in this subsection shall not begin before 12:00 Midnight three days before the
11 specific holiday, and shall be removed before 12:00 Noon the day following the said specific
12 holiday. For purposes of this section "special holiday promotions" is limited to the following
13 events or holidays:

14 Super Bowl
15 St. Patrick's Day
16 Independence Day

17 On Memorial Day and Labor Day only, where the holiday in question is a
18 national holiday celebrated on a Monday, the display of alcoholic beverages for such holiday
19 promotions shall not begin before 12:00 Midnight three days before the specific Monday holiday,
and shall be removed before 12:00 Noon the day following the said Monday holiday.

20 (C) *Holiday Season Promotions.* The display of holiday season promotions listed
21 in this subsection shall not begin before 12:00 Noon on November 1 of each year, and shall be
22 removed by 12:00 Noon on January 5 of the next year.

23 (D) Not more than twenty-five percent of a grocery store's total number of
24 shopping aisles may be devoted to aisle front special and holiday season promotions pursuant to
25 this Section; provided, however, that in no event shall the total number of said displays exceed
26 five.

The City Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

SECTION 4: If any provision of this ordinance is found by a court of competent jurisdiction to be invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is found to be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

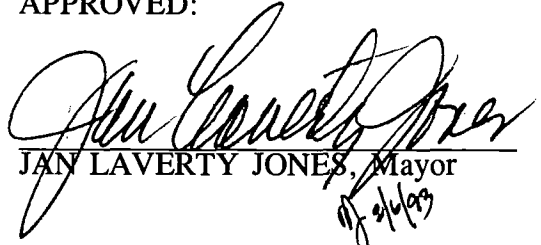

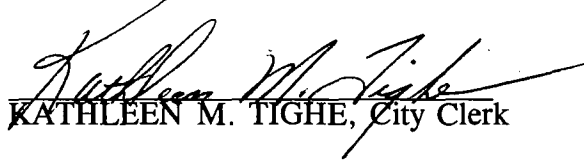

1 may be selected by the customer and purchased at a common check-out stand at which
2 nonalcoholic beverages may be purchased. No self-service shall be permitted in original sealed
3 or corked containers in quantities less than one pint, measured in the English system of weights
4 and measures, or in quantities less than three hundred seventy-five milliliters, measured in the
5 metric system of weights and measures.

6 (B) *Special promotions. The display of special promotions listed in this*
7 *subsection shall not begin before 12:00 Noon two days before the special promotion, and shall*
8 *be removed before 12:00 Noon the day following the special promotion. For purposes of this*
9 *section "special promotions" is limited to the following events or holidays:*

13 *Independence Day*
14 *Labor Day*

15 (C) *Seasonal promotions. The display of seasonal promotions listed in this*
16 *subsection shall not begin before 12:00 Noon on October 15 of each year, and shall be removed*
17 *by 12:00 Noon on January 5 of the next year. For purposes of this section, "seasonal*
18 *promotions" is limited to the following holidays:*

22 *New Year's Eve*

23 (D) *Twenty-five percent of a grocery store's total number of shopping aisles may*
24 *be devoted to aisle front special and seasonal promotions pursuant to this Section; provided,*
25 *however, the total number of said displays shall not exceed five.*

26 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause
or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or
invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the
validity or effectiveness of the remaining portions of this ordinance or any part thereof.

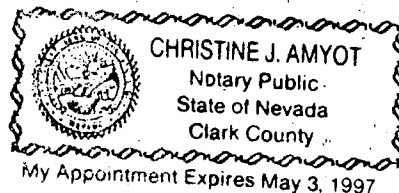

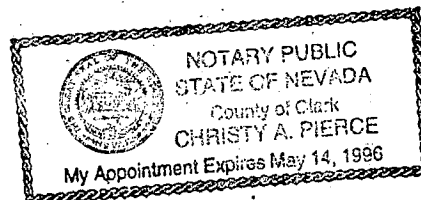

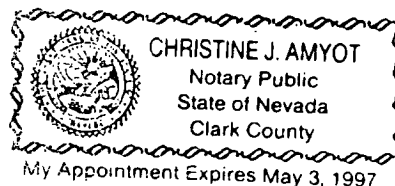
