THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA DOES
HEREBY ORDAIN AS FOLLOWS:

SECTION 1: The Master Plan of Streets and Highways provided for in Title 13, Chapter 12, Section 30 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended as follows:

Rancho Drive between Bonanza Road and Washington Avenue is reduced in width from 175 feet to 150 feet, consisting of 100 feet west of the centerline of Rancho Drive and 50 feet east of said centerline.

SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof.

The City Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

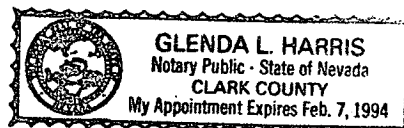

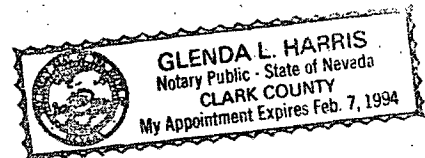
