Summary: Provides that the Director of the Department of Parks and Leisure Activities or His or Her Representative Serve as a Voting Member of the Arts Commission

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 2, Chapter 34, Section 40, of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

2.34.040: In addition to the nine voting members, the Director of [Parks, Recreation and Senior Citizen Activities] the Department of Parks and Leisure Activities or his or her authorized representative shall also serve [ex-officio] as a [nonvoting] voting member of the Arts Commission.

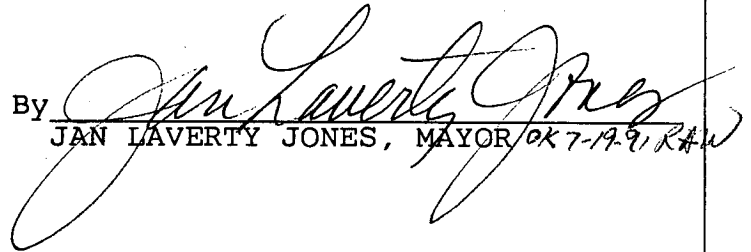
SECTION 3: If any section, subsection, subdivision paragraph, sentence, clause or phrase in this ordinance or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas, Nevada, hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be

1 declared unconstitutional, invalid or ineffective.

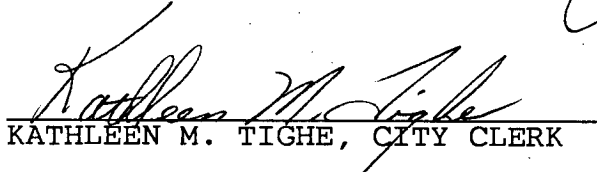

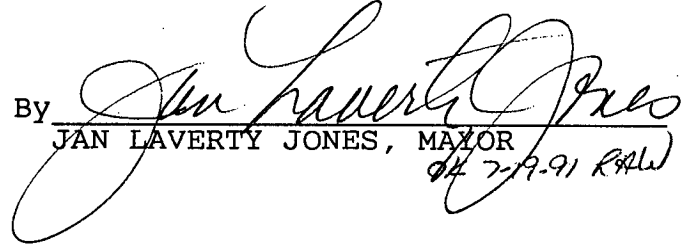

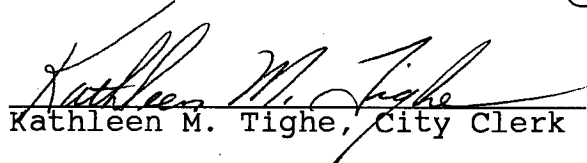
