AN ORDINANCE PROPOSING EXEMPTIONS FROM RESTRICTIONS ON OUTSIDE WATER USAGE FROM A PUBLIC WATER SYSTEM FOR THE PURPOSE OF IRRIGATION FROM THE HOURS OF 12:00 NOON TO 7:00 P.M. FROM MAY 1ST UNTIL OCTOBER 1ST OF EACH YEAR; PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO; PROVIDING PENALTIES FOR THE VIOLATION HEREOF; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith.

Summary: An Ordinance Which Proposes Exemptions From Restrictions on Outside Watering During Designated Months of the Year and Designated Times of the Day

THE CITY COUNCIL OF THE CITY OF LAS VEGAS, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 14, Chapter 8, Section 150 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

14.08.150: The provisions of 14.08.140 do not apply to:

(A) Hand watering;

(B) Irrigation of new lawns, for a period of thirty (30) days from planting or the date of installation;

(C) Irrigation by commercial gardens or plant nurseries licensed in accordance with Title 6 of the Las Vegas Municipal Code provided the licensee or his representative are personally on the premises at the time watering is taking place.

(D) Irrigation system testing after mowing to identify broken heads, and after repairs to flush lines, properly align sprinkler heads or to locate a reported leak. A test run should not exceed two (2) minutes and the individual conducting the test must be present and observe sprinkler performance.

1 (E) Syringing, which is a method used to cool down "hot
2 spots" under visible signs of stress, where one
3 station is run manually or on large irrigation pro-
4 jects by hand held remote irrigation controllers or
5 computerized central control for no more than
6 three (3) minutes. The individual operating the
7 sprinklers must be present and observe the
8 sprinklers running.

9 (F) Landscape irrigation audits where the application
10 rate and efficiency of an irrigation system is
11 being tested by aligning heads and placing cups
12 across the turf area and the amount of water caught
13 in the cups is measured. Testing run times of pop-
14 up spray heads are five (5) minutes; run times of
15 impact and rotor heads are fifteen (15) minutes.
16 The auditor performing the test must be present and
17 observe sprinkler performance.

18 SECTION 2: If any section, subsection, subdivision
19 paragraph, sentence, clause or phrase in this ordinance or any
20 part thereof, is for any reason held to be unconstitutional or
21 invalid or ineffective by any court of competent jurisdiction,
22 such decision shall not affect the validity or effectiveness of
23 the remaining portions of this ordinance or any part thereof.
24 The City Council of the City of Las Vegas, Nevada, hereby
25 declares that it would have passed each section, subsection, sub-
26 division, paragraph, sentence, clause or phrase thereof,
27 irrespective of the fact that any one or more sections, subsec-
28 tions, subdivisions, paragraphs, sentences, clauses or phrases be
29 declared unconstitutional, invalid or ineffective.

30 SECTION 3: Whenever in this ordinance any act is pro-
31 hibited or is made or declared to be unlawful or an offense or a
32 misdemeanor, or whenever in this ordinance the doing of any act

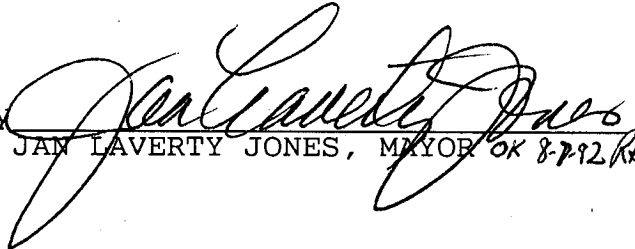
1 is required or the failure to do any act is made or declared to
2 be unlawful or an offense or a misdemeanor, the doing of any such
3 prohibited act or the failure to do any such required act shall
4 constitute a misdemeanor and upon conviction thereof, shall be
5 punished by a fine of not more than \$1,000.00 or by imprisonment
6 for a term of not more than six months, or by any combination of
7 such fine and imprisonment. Any day of any violation of this
8 ordinance shall constitute a separate offense.

9 SECTION 4: All ordinances or parts of ordinances, sec-
10 tions, subsections, phrases, sentences, clauses or paragraphs
11 contained in the Municipal Code of the City of Las Vegas, Nevada,
12 1983 Edition, in conflict herewith are hereby repealed.

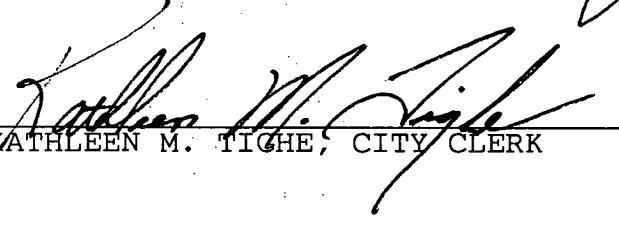
